Report for the ASC Faculty Senate

For activities from July 1, 2015 through June 30, 2016

## A. Curricular and Assessment Initiatives

## Curricular Approval Process

The College is continuously looking for ways to streamline and improve the curricular approval process. To that effect, a number of changes were either implemented in 2015-2016 or announced for future implementation in 2016-2017.

- On 9-18-15, Associate Executive Dean Steven Fink informed the ASCC that three changes would be implemented in 2015-2016:
o Elimination of the separate ASC Graduate Curriculum Committee. Going forward, graduate courses and programs would be reviewed by the regular divisional panels.
0 Elimination of the separate GE Service-Learning and GE Education Abroad ad-hoc panels. Going forward, requests for GE Service-Learning and GE Education Abroad would be reviewed by the regular divisional panels.
0 Elimination of the comment period at the ASCC. (Neither the original two-week comment period nor the 24 -hour comment period that was implemented later was ever used by the ASCC.)
- On 1-29-16, the ASCC voted to approve the creation of a second Arts and Humanities Panel to lighten up the heavy workload of the Arts and Humanities Panel starting AU16. This proposal was then submitted to Executive Dean David Manderscheid for his approval.
- On 4-29-16, Associate Executive Dean Steven Fink informed the ASCC of changes to be implemented in 2016-2017:
o Confirmation that the College would go forward with the creation of a second Arts and Humanities Panel.
0 Elimination of the Honors Panel. Going forward, Honors course and program requests will be reviewed by the Curriculum and Assessment Subcommittee of the ASC Honors Committee.


## Distance Learning

Since September 2013, ASCTech has reviewed distance learning course requests based on the last three sections of the Quality Matters rubric. Therefore, that part of the QM rubric has been readily available to ASC faculty, but that has not been the case for the rest of the rubric. On 1-29-16, Professor Janice Aski, Chair of the Arts and Humanities Panel, put forward a proposal to include the complete QM rubric in the ASC Curriculum and Assessment Operations Manual. Indeed, the Arts and Humanities Panel had noticed that syllabi for new distance learning course proposals that were created without consulting the complete QM rubric were lacking in necessary information for the students and were not structurally sound in terms of the on-line environment. Inserting the complete QM rubric in the manual for informational purposes would enable ASC faculty to develop pedagogically sound distance learning courses. The faculty of the other divisional panels reported that their panels had experienced issues with distance learning course requests as well and the ASCC approved moving forward with this proposal (with the proviso that some copyright issues be clarified first).

## Double Majors across Colleges

In June 2015, the Council on Academic Affairs approved the new policy allowing double majors across colleges. On 10-23-16, Associate Executive Dean Steven Fink informed the ASCC that a list of majors that would be appropriate to be used as second majors was being developed. Tagged degrees would not qualify due to their specific requirements. The list was finalized later in AU semester.

## Global Option

A few years ago, the university developed a framework for a curricular program that enables undergraduate students to acquire a substantial international experience in their major without adding time to degree. This experience is then documented in a student's transcript. Several Colleges have already adopted a Global Option certificate for their programs (e.g., Social Work, EHE, Business, John Glenn). Though the Office of International Affairs encourages college-wide adoption of the Global Option (GO), in 2015 an ad-hoc committee of the ASCC recommended against such a college-wide adoption for ASC but encouraged the consideration of division-level adoption of GO.

In AU 2015, the NMS Panel considered the issue of a division-specific GO model. (The benefits of GO programs appeared greatest in the NMS majors since many programs in SBS and Arts and Humanities already have a lot of international components; therefore, the discussion started in the NMS Panel.) The NMS Panel determined that even offering the option by division would be challenging as it did not seem reasonable to require a department to financially support GO without current student demand. Moreover, unless the majors were modified, students in these programs would also be unlikely to meet the GO goals without additional time to degree. Finally, much of the GO program appeared to overlap with ASC's current GE requirements and/or options that ASC students could achieve through minors.

Therefore, on 12-11-15 the ASCC decided to not support the development of a college-wide or division-specific GO model. However, the ASCC enthusiastically voted to support major-specific GO proposals. The Department of Women's, Gender, and Sexuality Studies had previously expressed interest in the program and would be encouraged to re-submit their GO major-specific proposal.

## Service-Learning Proposals

In December 2015, the College issued a call for proposals for the development of new undergraduate service-learning courses. Grant recipients would be expected to use a one-course release or a summer stipend to fully develop their proposed new service-learning course (ideally in SU16, AU16, or SP17). In April 2016, the ASCC met and reviewed five proposals. All five proposals were approved for funding:

- Katherine Borland (Comparative Studies), "Ohio Field Schools"
- Julia Jorati (Philosophy), "Teaching Philosophy in High School"
- Glenn Martinez (Spanish and Portuguese), "Press 1 for English, Oprima 2 para Español: Translation and Interpretation in the Latino Community"
- Miranda Martinez (Comparative Studies), "Studies in Ethnography"
- Mytheli Sreenivas (Women's, Gender, and Sexuality Studies), "Reproductive Rights and Justice"


## Team-Teaching Proposals

The College issued a third call for undergraduate team-teaching proposals in May 2015. The call was for courses to be taught first in AU16 or SP17. In December 2015, the ASCC met and reviewed five proposals. All five proposals were approved for funding:

- Art Education/(City and Regional Planning) 4674 "The City as Art"
- Comparative Studies/English 5980 "Ancient and Modern Narrative: Cognition, Affect, Ethics, Belief"
- English/Linguistics 5804 "Analyzing Language in Social Media"
- German/Japanese 2255 "Postwar Culture in Germany and Japan"
- Hebrew/Philosophy 3120 "Engaging Time: Philosophical and Rabbinic Dimensions of Temporality"


## Syllabus Template Elements

On 12-11-15, Professor Meg Daly, Chair of the ASCC, announced that suggested language for sexual misconduct/relationship violence and diversity would be included in the ASC Curriculum and Assessment Operations Manual.

## Assessment of General Education

Autumn 2015

- The Assessment Panel reviewed the following GE assessment reports submitted:
o Course Set S2 reports (Historical Studies, Literature, Writing \& Communication Level 2)
o Resubmissions from Course Set S1
o GE Service-Learning reports
o GE Education Abroad reports
o New GE course reports
o Psychology departmental report
- The Assessment panel Chairs met with representatives from the units selected for Course Set S3 (Social Science and Natural Science categories).
- The Assessment Panel Chairs met with representatives from the departments selected for departmental reports (Mathematics and Statistics).
- The Assessment Panel Chairs met with units that submitted GE assessment reports that did not provide all requested information and asked that revised reports be submitted Summer 2016.

Spring 2016

- Finished reviewing the GE assessment reports submitted in 2015.
- The Panel reviewed and discussed Tracdat, a new assessment management program purchased by Ohio State. Based on the organization of the program, the Panel determined that Tracdat was not the best option for General Education assessment. As a result, a Panel member suggested using Qualtrics for GE assessment and the Panel decided to start developing a Qualtrics survey over the summer to run a pilot during the 2016-2017 academic year.
- Draft GE assessment rubrics were developed and discussed by the Panel.
- A Panel member presented the draft GE assessment rubrics to the full ASCC with a request that the curriculum panels review and approve the rubrics.
- The Panel selected the GE categories, courses, and departments to request GE assessment reports from during the 2016-2017 academic year.
o Categories for Course Set S4:
- Cross-Disciplinary Seminar
- Foreign Language
o Departmental report: English, Writing and Communication Level 1

## B. Programs

## New Majors

## Moving Image Production BA

This new major focuses on live action and animation filmmaking practices. Specifically, it is designed to provide students with an understanding of the power and meaning of moving images as well as the necessary technical and analytical skills to produce such images. The BA is the result of a collaboration between several units in the College of Arts and Sciences: ACCAD (Advanced Computing Center for the Arts and Design), Art, Design, Film Studies, and Theatre. There are nine credits of pre-major courses, 38 credits of core courses, and 15 credits to fulfill a film studies minor for a total of 62 credit hours. The major prepares students for careers as independent artists in film and animation; cinematographers; producers, directors; editors and technicians; visual effects artists; video game artists; technical directors, employees in federal and state funding agencies; as well as media specialists/consultants. It also prepares students for graduate work and advanced research in the field. Admission to the MIP program will be selective (portfolio review and academic performance in the first year). Enrollment is expected to reach up to 200 majors at the end of year four.

## Music BS

The new BS enables students to combine a primary focus on music with non-music (mostly but not exclusively technological) interests. The major includes three tracks: (1) Computer Sciences: provides students with the knowledge to created software and hardware musical tools; (2) Sonic Arts: enables students to understand the ways in which technology influences the creation, production and reproduction of music; (3) Media and Enterprise: provides students with an understanding of how economic, social, cultural, and technological factors influence the musical experience. The BS pulls courses from eight different departments across campus. There are 37-38 credits of core (music and non-music) courses and between 27-35 credits for the tracks. The BS prepares students for careers as programmers, entrepreneurs, and various professions in the recording industry. It also prepares students for graduate work in fields like computer science, business, communication, and music technology. The School of Music expects to enroll around 5 students per year, at least initially.

## Major Revisions

## GE requirements in Art BA

At conversion, the GE requirements for the Art BA included three prescribed courses: Philosophy 2450 to fulfill Visual and Performing Arts; History of Art 2001 to fulfill the Historical Study requirement; and History 2002 to fulfill the Cultures and Ideas or Historical Study GE slot. This revision removes those required classes and allows the Art BA to adopt the generic/non-prescriptive GE requirements as used by the other ASC majors. The change allows the new double major rules to apply to the Art BA.

## Classics program changes (revision to Classical Humanities Concentration \& Greek and Latin Concentration in Classics BA \& revision to Ancient History and Classics BA)

The revision focuses on one course (CL4999/4999H) but impacts two concentrations and one major. For students in the Greek and Latin concentration and the Ancient History and Classics BA, CL 4999/4999H becomes a requirement. Most of these students continue on to graduate school. They, therefore, need substantial writing samples for their graduate applications and a strong foundation in professional research skills for their future careers. On the other hand, CL 4999/4999H becomes an elective for the Classical Humanities concentration (whose students will then increase their breath of knowledge in
other areas). In addition, the program revision increases the credit value of this course to 4 from 3 credits because the department (1) plans to increase emphasis on the acquisition of requisite research skills, which justifies the additional credit hour, and (2) hopes to encourage all of its students to strive to graduate with Research Distinction in Classics, an honor that requires 4 credit hours of $\mathrm{Cl} 4999 / 4999 \mathrm{H}$. This change increases the number of credit hours in Greek and Latin and Ancient History and Classics from 30 to 31 credits.

## Comparative Studies BA

A significant drop in majors prompted an extensive assessment of the program that revealed students' frustration with the complexity of and inconsistencies in the structure of the major, and a feeling that there were too many choices required of the students.
The main revisions are:

- Add a required one credit-hour introductory course to the major, CS 2099. This change increases the number of credit hours for the major from 36 to 37.
- Remove the Religious Studies concentration option (since there is now a Religious Studies BA).
- Simplify and align the structures of the five remaining concentrations.
- Remove translation requirement from the Comparative Literature concentration (to limit overlap with World Literature BA).
- Renumber several courses so that they align with the explicit understanding that 2000-level courses are introductory, 3000-level courses are theorizing or topical courses, and 4000-level courses are advanced and offer research opportunities.


## Computer and Information Science BS

The main revision is the reintroduction of the Technical Electives options, which are groupings of electives in particular areas (though there is also an individualized option) and which appear on transcripts. The Technical Electives had not been included at conversion, but due to their benefits (mostly they simplify advising) the Department of Computer Sciences \& Engineering has decided to reintroduce these. Furthermore, two small changes are included in the major revision: (1) ECE 2000 is replaced by ECE 2060 and (2) Philosophy 1138 ( 4 credits) can be taken instead of both Philosophy 1337 ( 3 credits) and CSE 2501 ( 1 credit).

## Dance BFA

The Department of Dance is raising the minimum GPA in the major from 2.25 to 3.0 . It is also raising the minimum grade for courses in the major from $D$ to $C$ - or higher.

## Political Science BA

The revision transitions thematic clusters into formal specializations and specifies these on student transcripts. The seven clusters are: (1) Democracy and law; (2) Political identities and allegiances; (3) Political economy and development; (4) Cooperation, conflict, and violence; (5) Inequality and justice; (6) Political leadership and reform; and (7) Political analysis. With this revision, students are now able to specialize in either one of the seven clusters or one of the four traditional subfields (American; Comparative; International Relations; or Political Theory).

## Religious Studies BA

A significant drop in majors prompted an extensive assessment of the program that revealed students' frustration with the complexity of and inconsistencies in the course offerings and an awareness that one of the sub-plans could not be completed under current staffing limitations.
The main revisions are:

- Eliminate the two tracks in "Study of Religions" and "Religions and Cultures," and replace by one plan. The Cross-Cultural Distribution requirement is retained from the first track and the Comparative and Interdisciplinary Requirement is retained from the second track.
- Create an Advisory Board consisting of faculty from across the College of Arts and Sciences that will oversee the major and ensure cross-departmental cooperation with regular course offerings.
- Assign a faculty advisor to each Religious Studies major.


## Romance Studies BA

The main revisions to the Romance Studies BA are:

- Make sure that each primary language has an ASC advisor and a faculty advisor.
- Simplify assessment plan. The most significant change is that each department is now responsible for the direct assessment (oral and written) of graduating seniors who have chosen their language as their primary language. The director of the program implements the indirect measures, which include an exit survey and the evaluation of grades in students' secondary and tertiary languages.
- Remove the major focus tracks in the primary languages from French, Italian, Spanish and Portuguese to increase flexibility and facilitate advising.
- Clarify the declared total number of credits listed for the major: The total number of credits is 41-48 hours.
- For Italian as a primary language, replace the requirement to have one 5000 -level course by an additional 4000-level course requirement.

## New Graduate Programs

## Contemporary Art and Curatorial Practice M.A.

The new MA housed in the Department of History of Art is intended as a 3-year curatorial training program that combines graduate-level coursework in modern and contemporary American and European, Asian, African and Latin American art with coursework in law, public policy, and arts administration. The MA includes at least 61 credit hours: 24 hours of core courses, $25-28$ hours of history of art (including curatorial) electives, 3 hours of theory elective, and 9 hours of law/public policy/arts administration electives. The program expects to enroll 5 students during the first year and aims toward a maximum entering class of 10 by the end of the fifth year.

## Graduate Program Revisions

## Communication PhD

The revisions are:

- Require two one-credit courses, COMM 6500 (Introduction to Graduate Studies) and COMM 7998 (Directed Research) in the first semester.
- Reduce the number of required electives from 54 to 51.
- Make COMM 6763 (Qualitative Research Methods) an elective instead of a core required course.
- Reduce the overall number of credits from 85 to 81 .


## Demography GIS

Two changes are made to the GIS:

- Take Sociology 8802 (Proseminar for Graduate Interdisciplinary Specialization in Demography) instead of the current Sociology 7884.09 (Seminar: Research Methodology).
- Take Sociology 7753 (Introduction to Demographic Analysis) instead of Sociology 7884.13 (Seminar: Population/Demography)


## NELC PhD

The revisions increase flexibility within the NELC PhD program to respond to student needs and faculty expertise. As a result the curriculum is more customized. Specifically, the grouping of requirements by area has disappeared and has been replaced by an emphasis on final qualifications. In the new program, students take an introductory course (NELC 5101), two theory/research methods courses (from a list of NELC, Comparative Studies, and History courses), at least eighteen (18) elective units in NELC, Arabic, Hebrew, Persian, or Turkish, and at least fifteen (15) units of credit at the 7000- or 8000-level among the courses beyond the MA. Beyond these 42 hours and 12 dissertation hours, courses are chosen in consultation with the student's Advisory Committee.

## C. Courses

From July 1, 2015 through June 30, 2016, $\mathbf{5 8 0}$ undergraduate and graduate course requests were processed through the College of Arts and Sciences. Details for course requests with the greatest curricular import are given below (pp. 7-18). No details are provided for more routine requests (e.g., addition of a campus of offering, most changes to prerequisites, corrections of typos).
