Based on the method of learning by teaching, the proposed course will have OSU students with a high level of Korean language proficiency provide online one-on-one lessons for learners from a non-profit Korean community language school and Lorain County Community College. This course will serve a dual goal of promoting deeper understanding of Korean language among OSU undergraduate students and supporting the rising demand for Korean language education in the local community.

Each OSU student enrolled in the course will be assigned to an appropriate number of language learners and conduct 15- or 30-minute online sessions for a total of one and a half hours per week. Then the entire class will meet with instructor once a week to review the recorded online sessions, discussing their pedagogical techniques and lesson plans. The process of preparing and reviewing their teaching activities under instructor's guidance will give students a strong incentive to improve upon their linguistic knowledge, which should commensurate with their level of proficiency.

Instead of creating a new course, this new service-learning course will be offered as Level 5 Korean already in the books (5103 in the fall and 5104 in the spring). Thus the new course can be offered as early as in the fall of 2018. It will be an elective that counts toward both minor and major requirements. It will not request GE status. Prerequisites: completion of Korean language level 3 or above; open to native Korean speakers.

The major community partner will be the Korean-American Community School of Central Ohio (KACSCO) based in Columbus. Since its establishment in 1977, KACSCO "has been dedicated to educating the Korean language and Korean culture to community members" and it is a non-profit organization without any association with religious groups according to their website (<a href="https://sites.google.com/site/columbuskoreanschool/about-us">https://sites.google.com/site/columbuskoreanschool/about-us</a>). Some individual faculty members at OSU have built long-standing relationships with KACSCO, but this course will be the first institutional support offered by the OSU Korean Program.

In conceiving this project, I consulted with some key members of KACSCO, including its directors, principal, and teachers. We agreed that the course should take on the adult classes, which would typically have about 20 adult learners enrolled in each semester. Unlike most school-aged pupils from Korean or Korean-American households, these adults do not have many opportunities to practice Korean outside the classroom. KACSCO faculty pointed out the adult learners would benefit greatly from online sessions focused on pronunciation and conversation practice. I plan to hold several meetings with KACSCO teachers to coordinate the lesson plan so that the online sessions with OSU students will be complementary to their curriculum. Flexibility of scheduling is another advantage of the online program for the working adult learners.

The OSU Korean Program has also been offering an online individualized instruction to a student from Lorain County Community College since the fall of 2017. We expect to continue with this partnership for another year at least. The service-learning grant would enable us to expand the online instruction to more students at Lorain and other educational institutions in the region.
