Arts and Sciences Curriculum Committee (ASCC)

Report for the ASC Faculty Senate

For activities from July 1, 2023 through June 30, 2024

## A. Curricular Initiatives

#### **General Education Bookends: Connection Seminar**

At its meeting on October 6<sup>th</sup>, the ASCC provided feedback to guests Dean Marymegan Daly (Assoc. Dean of Undergraduate Education), Dr. Melissa Beers (Senior Director, GE Bookends), and Ms. Allison Schultz (Instructional Designer) on a proposal to create a single, 1 CH course that would take the place of the Launch Seminar (GenEd 1201) and the Reflection Seminar (GenEd 4001) for transfer students who arrive at Ohio State with at least 45 semester hours of college credit, or have completed the OT36 or an Associate's Degree. As these students enter the university with all or most of their General Education requirements completed, the Office of Undergraduate Education felt that a different course would best support the goals and ELOs of the Launch and Reflection seminars for these students.

After providing informal feedback on October 6<sup>th</sup>, the ASCC voted to approve the proposed course with 4 contingencies and 2 recommendations on October 20<sup>th</sup>. Dr. Jennifer Ottesen, chair of the ASCC, reviewed the revised proposal in late January, and it was approved with one additional recommendation on February 9<sup>th</sup>.

#### **General Education Themes**

At its meeting on November 3<sup>rd</sup>, the ASCC discussed how pre-requisite requirements are evaluated as a part of General Education Themes course proposals. One of the guiding principles for General Education courses is that they should have few or no pre-requisites, thus making them available to a wide range of students at the university. Some units have presented a concern that, as Themes courses are intended to be advanced, it is virtually impossible to offer them in some units without significant pre-requisites.

After some discussion, the ASCC noted that the Subcommittees who review Themes courses do consider pre-requisites as a part of their holistic review of a proposal and evaluate each course's requirements on an individual basis. They also emphasized that a Themes course does not necessarily need to be advanced in a discipline, but rather should be advanced in its examination of the Theme itself. They find this distinction to be very important, and note that it allows for a broader approach to the design of an advanced course.

#### **General Education Themes: High-Impact Practice (HIP) Courses**

On Nov. 3<sup>rd</sup>, the ASCC voted to endorse a new submission form for courses seeking approval as HIP: Research and Creative Inquiry courses. This new form was created by the Themes Subcommittee chairs in conjunction with Bernadette Vankeerbergen, Assistant Dean of Curriculum, and based on the feedback of Themes Subcommittee members. The new form will allow course proposers to better explain how their course fits the requirements for an HIP course, and provide more relevant information to the Subcommittee members who are evaluating proposals.

#### **General Education Themes: COIL Courses**

Dr. Cindy Jiang (Senior Research Associate in the Office of International Affairs and COIL Coordinator) spoke to the ASCC at their meeting on November 17<sup>th</sup>. Her presentation focused on the COIL program's

defining characteristics. She also discussed how COIL courses seeking approval as 4-credit hour High Impact Practice Themes courses could achieve the aims of the Global and Intercultural Learning: Abroad, Away and Virtual HIP category. The Committee found the conversation with Dr. Jiang to be very informative.

#### **Program Assessment**

On October 6<sup>th</sup>, the ASCC heard a presentation from Dr. Daniel Seward, Assessment Coordinator for the College of Arts and Sciences. Dr. Seward presented information about his function within the college, the resources available to units via the Arts and Sciences Curriculum and Assessment Services (ASCCAS) website, and upcoming assessment initiatives within the college.

## **Religious Accommodations Statement**

On September 8<sup>th</sup>, 2023, the ASCC discussed the university's new required syllabus statement regarding religious accommodations for students. Though some members of the Committee expressed concerns about the statement's compliance with Ohio law, they ultimately voted to accept the statement presented by the university, require its inclusion in all syllabi reviewed by ASCC Subcommittees, and authorize ASCCAS staff members to update the ASCC-approved Statement on Religious Accommodations when the university statement is updated.

An updated and expanded religious accommodations statement was brought to the attention of the ASCC in February, and resulted in a discussion with Norman Jones, Vice-Provost and Dean for Undergraduate Education, on March 1<sup>st</sup>. The Committee expressed their concerns about the quality, length, and redundancy of the updated statement to Provost Jones. While the ASCC voted to approve the new university statement as a required element for all ASCC syllabi, they formally asked that Provost Jones and his staff consult with the Office of Legal Affairs to find out if a more succinct and concise statement could be drafted. [The Provost's office subsequently informed the ASCC that the language would not be changed at the current time.]

#### **Syllabus Statements**

As a part of the above discussion surrounding the religious accommodations statement on March 1st, the Committee voted to continue requiring that mandatory syllabus elements be included on syllabi in their entirety; a hyperlink to the statements on a webpage is not sufficient. In addition, the ASCC authorized the ASC Curriculum and Assessment Services staff to change recommended and mandatory syllabus statements on the ASCCAS website and in the ASCC Operations Manual when those statements are revised by their office of origin. These future changes will not require a vote of the ASCC, but the ASCCAS staff will inform the ASCC of any changes at their next regularly scheduled meeting.

#### **Distance Education**

At the ASCC meeting on October 20<sup>th</sup>, the Committee heard from Elizabeth Marsch (Director of Distance Education) and Jeremie Smith (Distance Education Coordinator) regarding the evaluation of proposals for distance learning courses. Ms. Marsch and Mr. Smith explained that the national conversation surrounding distance education is moving away from the terms "direct" and "indirect" instruction and instead focusing on regular and substantive interactions (RSI) between students and instructors. After reviewing the materials provided by Ms. Marsch and Mr. Smith from the Higher Learning Commission, the ASCC indicated their support for the Office of Distance Education to develop a new model for review and evaluation of distance learning courses.

As a result of this conversation, the ASCC sought input from students on the topic. Lillian Wang (ASCC Undergraduate Student Representative) met with her colleagues on the Arts and Sciences Student Council in mid-January and led a discussion on Distance Learning. She shared a summation of this conversation with the Committee on January 19<sup>th</sup>, noting that students appreciate direct instruction in both the synchronous online and in-person classroom because it allows them to connect with their instructors, ask questions in a real-time environment, and learn in a more structured, accountability-driven setting. Students do still appreciate asynchronous online courses for their convenience, but note that direct instruction can be more difficult and less effective in this setting.

On Feb. 2<sup>nd</sup>, Ms. Vu and Mr. Smith returned to the Committee with a newly developed Distance Learning Cover Sheet and Distance Learning Syllabus Template. After some amendments based on input from the Committee, the new Cover Sheet and Template were approved for immediate implementation.

## **Rules Surrounding Certificates**

On October 3<sup>rd</sup>, the ASCC was asked to provide feedback on the rules surrounding grading for courses used in partial fulfillment of the requirements for a certificate program. Dean Andrew Martin explained that the faculty who originally drafted the rules for certificates required that courses used toward certificates have letter grades (A-E), but they inadvertently failed to consider S/U grading. Since courses graded S/U can be used toward other programs at both the graduate and undergraduate levels, the Committee on Academic Affairs felt that some S/U coursework should be allowed, but asked for the recommendation of the ASCC. The Committee voted unanimously to recommend that CAA allow 3 credit hours of course work graded S/U to be used toward certificates of all types.

## Rules Surrounding Dual Degrees and Double Majors Under the New General Education

Mary Ellen Jenkins (Assistant Dean of Advising and Academic Services) presented to the ASCC on December 1<sup>st</sup> regarding questions that academic advisors in the college had posed about dual degrees and double majors. Dean Jenkins explained that, under the Legacy GE, dual degree students were not allowed to use the same course to meet a general education requirement and a major requirement, nor could the same course be used in both majors. However, students completing a double major *have* been allowed to use the same course in the GE and their major or in two majors, as long as each major contained 18 unique hours. The Committee was asked to consider whether these policies should remain the same or be altered in light of the new General Education Program. After some discussion, the Committee asked that Dean Jenkins return to the Committee with some examples of scenarios for both the dual degree and the double major under the new General Education so that the Committee could make a more informed decision on these policies.

On February 16<sup>th</sup>, the ASCC continued this conversation with a focus on the questions surrounding the double major. After some discussion, the members of the Committee declined to allow GEN Foundations courses to cross with the major for students in a double major, though they would be open to re-considering this policy if data shows that some crossing between the GEN Foundations would be beneficial to students' overall programs of study. Students will continue to be allowed to cross Themes courses with their majors within university guidelines.

At their April 19<sup>th</sup> meeting, the ASCC returned to the discussion of GEN overlap for Dual Degree students. After discussing several options, the Committee voted to allow Theme overlap with either or both majors with a limit of 6-credit hours for students pursuing a dual degree. Additionally, ASCC asked that it be specified in the ASC Faculty Rules that students may not "split" a course's credit hours between two sets of requirements (e.g., a 4-CH course may not have 1 CH put towards a student's major

program and 3 CH put toward the GE or another major). This option was chosen, in part, because it maintains the integrity of the university's rules surrounding the "crossing" of courses between the GE and the major, while also requiring that students who wish to earn a dual degree have a more robust academic program than students who choose the option of a double major.

Finally, on May 5<sup>th</sup>, the Committee voted to adopt the following language to clarify degree requirements in these situations:

In the case of a student pursuing multiple majors, course work may overlap between the majors, provided that each major department allows such overlap and that each major has at least 18 unique (non-overlapping) semester hours. Similarly, there may be overlap between the major course work and the GEN Themes courses within the following parameters:

- 1. Major courses may only overlap with the GEN Themes as long as there are at least 18 unique, non-overlapping semester hours in each major.
- 2. A course may only fulfill a requirement in two of the aforementioned categories (i.e., it may count in both majors or one major and the GEN Themes, but it cannot be used in two majors and the GEN Themes).

Students may not overlap major coursework with GEN Foundations requirements.

In the case of a student pursuing multiple degrees, at least 30 additional semester hours (beyond the 121 hours required for a single degree) must be earned for each additional degree sought, and at least 18 of the additional 30 hours must be ASC or ASC-approved upper-division course work. The GEN requirements and the college requirements for each degree must be fulfilled. (For example, a student earning both BA and BS degrees is required to complete calculus, which is not required for the BA, because such coursework is required for the BS.) Students may overlap up to 6 semester credit hours of GEN Themes courses with their major coursework, within the following parameters:

- 1. Students may overlap two 3-credit hour GEN Themes courses or one 4 or 5-credit hour GEN Themes course. In the later case, they may not "split" credit hours for a single course and overlap a portion of a second 3, 4, or 5-credit hour GEN Themes course with major coursework.
- 2. A course may only fulfill a requirement in two of the aforementioned categories (i.e., it may count in both majors or one major and the GEN Themes, but it cannot be used in two majors and the GEN Themes).

## Requirements for the Bachelor of Arts and the Bachelor of Science

At its meeting on March 22<sup>nd</sup>, the ASCC discussed the distinction between the Bachelor of Arts and the Bachelor of Science. Currently, the only difference between the two degrees is the requirement for Bachelor of Science students to complete Calculus I (Math 1151 or equivalent). Dean Andrew Martin told the Committee that Dean David Horn is interested in considering other options for the Bachelor of Science and a "sister" requirement for the Bachelor of Arts. The ASCC discussed several options and supported the idea of creating two separate groups to discuss this (one for the BA and one for the BS), stressing that communication between the two groups will be essential.

## **Ohio Prison Education Exchange Project**

On February 2<sup>nd</sup>, the ASCC heard a presentation from Dr. Mary Thomas and Dr. Tiyi Morris, Co-Directors of the Ohio Prison Education Exchange Project. Drs. Morris and Thomas gave an overview of the program and how it benefits students who are incarcerated at a variety of facilities in Ohio, as well as traditional students from a variety of OSU campuses. Although combined enrollment courses where both populations of students learn in the same classroom have existed for some time, up until now students could not earn a degree while incarcerated. Beginning in AU24, Ohio State will become the first liberal arts education program in Ohio's prison system to offer a 4-year degree – a Women's, Gender, and Sexuality Studies BA that will be available to students at the Ohio Reformatory for Women. Over 20 OSU instructors from a variety of campuses have completed training and hope to teach courses in the program within the next 2-3 academic years. The program will also provide support, counseling, and transition services for students, engage in outreach to student organizations, and educate the Ohio State community about the impact of mass incarceration.

At its April 19<sup>th</sup> meeting, the Committee formally voted to endorse the proposal to offer an embedded Bachelor of Arts with a major in Women's, Gender, and Sexuality Studies at the Ohio Reformatory for Women in Mansfield, OH.

## **Online Liberal Arts BA Program**

On March 1<sup>st</sup>, the Committee held an informal discussion about the creation of a transfer-friendly bachelor's degree program in the College of Arts and Sciences. This program would be aimed at students who have exited a college or university without completing a degree. While the Committee was highly supportive of this program, they did not support the idea of making this a "tagged" degree as a means of separating it from programs open to all student populations.

#### **Election of a New Chair**

On April 19<sup>th</sup>, 2024, Dr. Ila Nagar (Associate Professor, Department of Near Eastern and South Asian Languages and Cultures) was nominated to serve as the new Chair of the ASCC. She was subsequently elected to the position.

## C. Courses

From July 1, 2023 through June 30, 2024, **591** undergraduate and graduate course requests were processed through the College of Arts and Sciences (a decrease of 106 courses from 2022-2023 [697 course approvals], but still an increase over the 556 requests in 2021-2022). Details for course requests approved through faculty Subcommittees are given below (pp. 5-17.) More routine requests (e.g., addition of a campus of offering, most changes to pre-requisites, corrections of typos, one-time course requests) are fast-tracked to the Registrar's Office.
