The semester conversion proposal for the South Asia Studies minor was unanimously approved.

Here is a summary of the votes/feedback:

First, I think we should change the PACER table to align with Val's statement that only the top line is filled out, and second the "Program Plan Code Abbreviation" is given as SASIAST, but probably should have a "MN" appended to it. I vote to approve as well.
