Thanks for your feedback on our proposed course: Criminal Investigation: SOC 4189.03. We have revised the syllabus to address the committee's concerns. The most significant change is the addition of a required textbook and additional required readings which will be made available on Carmen. We have also added a couple of new topics on investigative techniques for specific types of crime (property crime, crimes against persons, and terrorism). These changes are reflected in the revised course schedule.

In addition to being a more appropriate set of requirements for a 3 hour class, I think these additions will definitely enhance students' learning experience and improve the quality of the in-class discussions and the assignments/course project.
