Requirements:

1. Five Examples of Course Topics

Select 5 course topics, and find an example of each, due on the date that topic is discussed. The example can come from the newspaper, television, daily life, literature, other media source, or your memory. Turn in the example (newspaper clipping or written description) with your brief notation (one sentence is fine) of the way that your example fits the topic. These do not count if turned in late. The topic will be described briefly at the end of the previous class. (Total of 5 points possible)

2. Mid-term exam

The Mid-term exam will cover the topics introduced in both Tannen and class discussion. The exam requires a brief definition and example. (Total of 15 points possible)

3. Term paper proposal

Your idea for the term paper is due **November 2**. You can change your idea if necesary after that date. The proposal itself, due when you have collected the data, should include the data for the project and the contextual information about the data: how collected, where, from whom (detailed information as relevant about age, occupation, ethnicity, race, regional identity, religion, etc), in what situation, and referring to what circumstances, cultural background. The proposal has a final deadline of **November 16**, but you are strongly encouraged to turn in the proposal as early as possible so that you can get responses and suggestions for the term paper. (Total of 30 points possible)

4. Term paper

The term paper is your major work for the course and is based on a collection of some piece of communicative interaction (a conversation, an event, a text). The paper has four components:

- a) background information about the data (see the proposal); you can revise your proposal for the term paper.
- b) a transcription of the data
- c) an analysis of the transcription
- d) a discussion on a particular topic of analysis (probably one of the topics introduced in class) The term paper is due in class **December 2** (total of 30 points possible)
- 5.Oral presentation of your term paper

Using either an overhead transparency, a tape recording, or photocopies of the transcription, each

student will have an opportunity to present his/her data for class discussion. You can make your presentation anytime after you turn in your term paper proposal. For the presentation, describe what you collected and suggest what interests you about this data. (Total of 5 points possible) 6. Final exam

Definition and examples of the remaining topics covered in class (after the mid-term) and a one-page discussion of someone else's oral presentation. (Total of 15 points possible)
