Dear Holly,

On Friday, February 7, the ASC Arts and Humanities Panel reviewed the revised request to add GE Cultures and Ideas to Architecture 2300/2300E and Landscape Architecture 2300/2300E.

I am happy to report that the request to add GE Cultures and Ideas was unanimously approved with one small recommendation:

The instructions for the formal analysis paper 1 do not clearly deal with GE Cultures and Ideas. However, the grading rubric clearly does link to the GE category. Suggestion to clarify the link with GE Cultures and Ideas in the instructions. This might possibly be achieved by developing the short paragraph (p. 2 of the instructions) that lists 3 points that should be included in the text. If these 3 points could more strongly link to the language of the expected learning outcomes of the GE Cultures and Ideas, it is likely that the outcome (the formal analysis paper) will in turn be more related to the GE Cultures and Ideas expected learning outcomes.

Please note that the requested effective term for the four course changes is AU14. However, course changes needed to be at the Office of the University Registrar by February 1 (see deadlines here: <http://asccas.osu.edu/curriculum/important-deadlines>). Please let me know if it is OK that I change the date to SP15. If that is not acceptable, please e-mail me a rationale for why the change needs to occur for AU14 semester with a petition appealing the deadline. I will attach that document in curriculum.osu.edu.

Provided the course request is subsequently approved all the way through OUR, Architecture 2300/2300E and Landscape Architecture 2300/2300E will have GE Cultures and Ideas starting AU14 or SP15 (see my question above).

Please know that the GE assessment plan of the courses will need to be implemented each time the courses are offered and GE data gathered. After the second offering of the courses, the unit will be asked to submit an initial report summarizing GE assessment results of those first two offerings (following the format of sections I and II of the Assessment Report Requirement in Appendix 6 of the ASC Curriculum and Assessment Operations Manual [p. 75] https://asccas.osu.edu/sites/asccas.osu.edu/files/ASC_CurrAssess_Operations_Manual.pdf). Our program assistant Danielle Hogle (hogle.12) can help the unit with any aspect of the GE assessment requirement. She will also make sure to contact the unit before the courses are offered and provide any assistance that the faculty member(s) may need. Could you please communicate this information to the faculty member(s) who will be teaching the course?

The course will next move to the full AS Curriculum Committee for the standard 2-weeks comments period.
