Rachel,

On Tuesday, November 26, the ASCC Arts and Humanities Panel reviewed two new course proposals for Spanish 4568 and Portuguese 4550 and three course change proposals for Portuguese 5510, 5520, and 5530.

The Panel unanimously approved Spanish 4568. This proposal will next move to the full ASCC for the standard 2-weeks comments period.

The Panel did not take a vote on the Portuguese proposals but would like the following points to be addressed first:

1. Portuguese 4550:

- Remove D- in grading scale as it is not a grade at OSU.
- How many extra-curricular activities do students need to attend to obtain 5%?
- The Panel agrees that this course can be approved as such with the 2 recommendations in italics above. However, the Panel will hold off advancing the course for now as there is some overlap between materials taught in 4550 and 5520 and the Panel has some concern about undergraduate students being able to take both courses (see notes on 5520 below). In case SPPO wishes to revise 4550 as the Dept is working on addressing the issues in 5510, 5520, and 5530, the course is not advanced for now.

2. Portuguese 5510:

- Form in curriculum.osu.edu: prerequisite information currently says: "Prereq:
 Portuguese 3450 (450) with a C- or better; Grad standing or permission of instructor."
 Shouldn't this say, ""Prereq: Portuguese 3450 (450) with a C- or better or Grad standing or permission of instructor"?
- Remove D- in grading scale as it is not a grade at OSU.

 The Panel believes this should read, "Because of the overlap between the content and
 goals of 4551 and 4552 we will withdraw <u>both</u>."
