Thank you for your response to my letter dated October 25<sup>th</sup> regarding the addition of a new specialization, Arts Education, to the PhD program in Arts Administration Education and Policy. #### PhD Arts Administration Education and Policy: New Specialization

Karen,

The Graduate School Curriculum Committee (GSCC) met on October 23 and, among its agenda items, considered the proposal to add an Arts Education specialization to the doctoral program in Arts Administration Education and Policy. I'm writing here to summarize the GSCC discussion of the proposal and to outline the next steps in the approval process.

The logic of adding a specialization for doctoral students pursing art education to provide them appropriate recognition for their study was self-evident. Unlike your Masters programs, which each have titles of appropriate identity (Policy and Administration, Art Education) the name change of the doctoral program (from Arts Education to Arts Administration Education and Policy) has inadvertently camouflaged the identity of the art education students. On the other hand, students pursuing the doctoral specialization in Cultural Policy and Arts Management already have a transcriptional designation which documents their study.

• The GSCC felt it would be helpful if the full curriculum of the specialization were presented. From what I have been able to reconstruct from semester conversion documents, the curriculum consists of Core (15 cr hrs), Research (5), Theory & Concepts (6), Specialization (12), Electives (6), Candidacy Exam (3) and Dissertation (6). This curriculum totals to 53 hours (my assumption is that students have 30 credit hours from a previous Masters). A table listing of the full curriculum and credit hour requirements would prove beneficial. One possibility could be submitting an advising sheet for students pursuing this specialization. As well, a side-by side comparison of the two specializations is another option.

Please submit a revised copy of the proposal to me. The GSCC would like to have a final look at the updated version prior to its moving forward in the approval process. The proposal should then be ready for review by the Graduate Council. Following Graduate Council, the proposal will be released to the Council on Academic Affairs for their review.

Dear Dean Herness,

As Graduate Studies Chair for the Department of Arts Administration, Education and Policy (AAEP), I am requesting that the Graduate School formally recognize those students who successfully complete the requirements for a Graduate Specialization in **Art Education**. This involves the doctoral application of existing courses that students in the doctoral degree program in Arts Administration, Education and Policy can select from as part of their interdisciplinary studies. The need for a Graduate Specialization in Art Education has arisen due to a department and PhD Degree name change (from Art Education to AAEP) along with the semester conversion. While the Graduate Specialization in Cultural Policy and Arts Management was created under the previous degree name of Art Education, the switch to a degree name of AAEP has eliminated students' opportunity to be formally recognized for specializing in Art Education. We wish to rectify this immediately by offering this new Graduate Specialization in Art Education, providing students the option of specializing in **either** Cultural Policy and Arts Management (existing), Museum Education and Administration (existing), **or** Art Education (proposed new specialization) under the doctoral degree of AAEP.

We have offered a PhD in Art Education for decades, with many of the most highly regarded scholars recognized in the field of Art Education counted among our alumni. Our doctoral program was built on Art Education; we simply overlooked the need for offering this as a formal specialization when we changed the name of our degree (and department). We have a plethora of required and elective courses covering this area of specialization, and many current and new students are continuing to work in this area. Additionally, the Art Education Graduate Specialization will provide a transcript designation necessary for our students seeking employment in Art Education positions in higher education, in particular.

Our proposed formal specialization in Art Education, built on the previously focused degree in Art Education, offers students opportunities to deeply explore a range of issues, theories, and research from both national and comparative perspectives, to critically explore the growing and evolving field of art education based on schools, museums, and community spaces. Our Art Education doctoral curriculum provides a model for universities internationally as well as for K-12 public and private schools.

This specialization requires students to enroll in five courses from the following required list (for 15 semester hours), to select elective courses that pertain to art education (for 12 semester hours), as well as to register for dissertation research hours that involve the study of an identified issue in art education. All courses listed below were thoroughly vetted in the semester conversion process, many of them either altered minimally from a quarter-based course, conflated, or provided new to fill gaps identified in the semester conversion process.

### **Reactivation Policy**

Students who go two years without registration or do not complete their degree within six years must petition the Graduate Studies Committee for reactivation. It may decide to reactivate or deny reactivation. It may also decide that reactivation requires additional study of recent developments in the field. Reactivation is needed for graduates seeking continuing education courses.

#### **Continuous Enrollment Policy**

All students who successfully complete the doctoral candidacy examination are required to be enrolled in every semester (summer session is excluded) until graduation. These students must be enrolled for at least three credits per semester. This policy is effective for all students who were admitted to the Graduate School Autumn Quarter 2008 and after and for students admitted prior to Autumn Quarter 2008 who did not enroll for 2 years.

While the Graduate School and the individual graduate programs will monitor the enrollment of all post-candidacy students, it ultimately will be the responsibility of each student to ensure that they are meeting the enrollment provisions of this policy.
