Re: Health, Environment, Risk, & Science Communication Minor

The School of Communication would like to propose the following minor to begin in Spring 2015. The faculty of the School has provided overwhelming support for the creation of this new undergraduate minor program. Faculty discussions of the future of the communication program served as the impetus for this proposal. New faculty hires in the areas of health and environmental communication enabled the department to determine the feasibility of development the minor. In addition, the popularity of the new course on Science Communication suggests that the demand is there among students to study health, environment, risk and science communication. In addition, discussions with faculty in the School of Environment and Natural Resources suggest that they perceive a need among their students for such a minor. Likewise, faculty in the College of Public Health, College of Veterinary Medicine, and College of Food, Agricultural, and Environmental Sciences were queried and they suggested there would be a demand for the minor among their students as well.

*Rational/purpose of the minor*. The minor in Health, Environment, Risk, and Science Communication provides students with an understanding of the role of communication in health and health care, science, and the communication of risk. All of these areas deal with the communication of complex information that has implications for people's well-being and safety.

The transmission of complex information to the public is becoming increasingly important as recent debates about climate change, SARS, or the HPV vaccine highlight. The Ohio State University is in a unique position to propose this minor. Traditionally, science, environmental, and health communication are considered separate programs and universities tend to develop programs in one of these areas. There are a few universities that have an emphasis in both science and environmental communication, but these programs are traditionally housed in Agriculture Colleges (e.g., Cornell, University of Wisconsin). Ohio State is unique in that we have a strong faculty across these related domains.

The proposed minor will provide an opportunity for students across the university to learn more about how complex communication is effectively communicated via media campaigns, new communication technologies, and interpersonal communication. Given the increased importance of communicating complex information, this background will place OSU students in a unique position in a competitive marketplace. The Minor should help create linkages between academic units that traditionally have not had much contact here at Ohio State. Hopefully, this will lead to fruitful collaborations with faculty across these different programs. Based on reactions from a number of departments as we sought concurrence, we anticipate 50-75 students enrolled in this minor once it is up and running.
