Subject: Proposed new course Econ 5860, Health Economics

I strongly support the new course proposed by Professor Kurt Lavetti, Econ 5860, Health Economics. At present, the department does not have any courses in this important area. The course will be targeted at advanced economics students and students whose interests are in healthcare related fields. The prerequisites are Intermediate of Microeconomics (Econ 4001) and Introduction to the Practice of Statistics (Stat1450) or Introduction to Statistical Analysis (Stat 2450). With the implementation of the Affordable Care Act, many areas of study will be affected by the changing economic environment in health care. Students considering employment in both the private and public health care sectors will benefit in having a strong background in health economics.

The course is well designed to engage students in state-of-the-art research methods in the analysis of interactions among providers and consumers of health and medical care, and the role of government in regulating the health care. These are important and topical issues, and Professor Lavetti is an expert who can provide interested and qualified students with an unusual opportunity to learn how economists use modern quantitative methods to study these issues.

The Department of Economics will support the offering of this course on a regular basis.

Health Economics (Econ 5860)

This is an introductory course to the field of health economics. Students will learn how to apply concepts that were taught in introductory and intermediate microeconomics to problems that are faced in health and medical care. We will focus in particular on individual demand for medical care; health insurance; markets for, and institutional features of, health care providers; measuring and pricing quality in healthcare; and health care reform policies such as the Affordable Care Act. The emphasis in the course will be primarily on US health policies and institutions, but we will also discuss comparisons between the US and international health care systems.

Required Reading:

The textbook for the course is Folland, Goodman, and Stano, *The Economics of Health and Health Care*, 7th Edition, 2013 (denoted FGS in reading list). Earlier editions of the textbook appear to be fairly similar and you are welcome to use them, but if you use an earlier edition it is up to you to be sure that chapter numbers and topics correspond to those on the course schedule and lecture notes. A copy of the 7th edition will be available in course reserves.

Your Money or Your Life, by David Cutler, Oxford University Press, 2005.

The textbook will be supplemented with additional articles and research papers, which will be posted on the course website. Notes and lecture slides will also be posted on the course website, usually a day before class. Please check the website regularly for readings and course updates.

Prerequisites:

Students should have completed Econ 4001 (Intermediate Microeconomics Theory). It is also recommended students have a basic knowledge of statistics, Stat1450 (Introduction to the Practice of Statics) or Stat 2450 (Introduction to Statistical Analysis).

Problem Sets:

There will be 4 homework assignments, each worth 5%. The assignments will be made available on the course website, and will be due at the beginning of class one week after they are assigned. You may discuss the assignments with others, but you must write your own answers independently. Late assignments will lose at least 50%. Solutions will be posted on the course website the day after the assignment is due. Once solutions are posted, late assignments will not be accepted.

Exams:

There will be two in-class exams. The midterm exam will be held on (DATE TBA), and will cover material to that point. The final exam will be held on (DATE TBA) and focus primarily on material covered after the midterm, but will include some material and concepts covered in first half of the course. There will be no make-up midterms or final exams, so please plan ahead.

Any requests for an assignment or exam to be re-graded must be submitted on paper in writing. Please take at least a day to think about the question, and you may submit a request for a re-grade no sooner than 24 hours and no later than 1 week after the assignment or exam has been returned. The entire exam or assignment will be reviewed and re-graded.

Health Economics (Econ 5860) Course Proposal

Rationale

The Department of Economics does not currently offer an undergraduate course with a focus on the economics of the U.S. healthcare system or health policy in general. The course proposed by Professor Kurt Lavetti will provide a richer curriculum for students in our major and supplement knowledge for students studying other areas healthcare.

Course objectives

This is an introductory course to health economics. Students will learn how to apply concepts introduced in our principle and intermediate microeconomic courses to problems that are faced in the health and medical care systems. The course will focus in particular on individual demand for medical care; health insurance; markets for healthcare and the institutional features of healthcare systems; health care providers; measuring and pricing quality in healthcare; and health care reform policies such as the Affordable Care Act. The emphasis in the course will be primarily on US health policies and institutions, but class discussion will also make comparisons between the US and international health care systems.

Relationship to other Courses/Curricula

Economic 5000-level courses expand on basic economic theory and develop the methods and techniques for analyzing the economic world. Econ 5860 would improve the current economics curricula as a course that applies the knowledge and skills developed in intermediate level in a specific area of economics. As a 5000 level courses, health economics could supplement the course offerings for graduate students in public policy and public health programs.

David,

We are more interested in being cooperative and collaborative rather than adversarial. So, rather than oppose your current course proposal, we will reverse our decision, but first consider the following so both units have clarity and comfort surrounding this issue:

1. Your proposed course will be aimed at upper level undergraduate economics majors and require econ prerequisites. The focus will be advanced economics and not health policy.
2. We will be allowed to offer an undergraduate health econ & policy class that covers both the economic intuition behind healthcare and health policy reforms (it would still have economics in the title). This one would require no economics pre-requisite and would be aimed at undergraduates who are just generally interested in health economics and policy, as well as, potentially serve as required/elective course for other undergraduates programs.

Dear Michael,

I am sorry to learn of the opposition of the College of Public Health to our proposed course in Health Economics. I would like to explain why we think this course makes sense for us, and why it is very unlikely to draw students away from your courses.

1. Our course is aimed at upper-level undergraduate economics majors. Hence the prerequisites: Econ 4001 (intermediate microeconomics) and Stat1450 (Introduction to the Practice of Statistics) or Stat 2450 (Introduction to Statistical Analysis). You do not offer an undergraduate-level course in health economics, so we are certainly not attempting to poach on any of your existing courses. If you are concerned about hypothetical loss of enrollment in case you offer a 5000 level course in the future, we have no objection to a requirement that your students must take your health economics course, should you offer such a course in the future.

2. Our undergraduates are not eligible to enroll in your Health Economics course, 7602, which requires graduate standing. Hence, there is currently no option for them to take a course in health economics. Our undergraduates are also ineligible for 7601, which is limited to students who have completed 6611, which itself is open only to Public Health majors.

3. Health economics is squarely within the mission of the Department of Economics, as a crucial and growing part of applied microeconomics. Indeed, we were authorized by the College of Arts and Sciences to hire two health economists, and we have recently done so. Virtually all of the top 30 economics departments have health economists on their faculty, and this is particularly the case for the highest-ranked departments. Many of these health economists collaborate on research and teaching with health economists located in colleges of public health. We would be open to such collaboration with your college.

We would be glad to discuss this with you to learn more about your concerns.
