Course description: this course is an introduction to consciousness with a focus on the interactions between philosophy, psychology, and neuroscience. Topics will include concepts of consciousness, the hard problem of consciousness, neural correlates of consciousness, global workspace theories, higher-order theories, representational theories, change blindness, the persistent vegetative state, the unity of consciousness, the function of consciousness, and the role of consciousness in perception, cognition, introspection, action, and free will.

Course requirements: grades will be based on attendance and participation (25%) and three short 5-6 page papers (25% each). All three papers must be completed in order to pass the course. Late papers will be penalized by a third of a letter grade per day.

Course attendance and participation: this is a discussion-based class and a so significant portion of your final grade will be based upon attendance and participation. Students are expected to attend all classes, to complete the assigned reading in advance, and to participate regularly in class discussion. A record of attendance will be taken. Please turn off laptops and other electronic devices during class.

Unfortunately, it turns out that the way ASC works right now, enrollments in crosslisted course are credited based on what version of the course students sign up for. So this does not seem like a viable arrangement to me, until ASC reconfigures the enrollment structure, or unless Psychology is prepared to commit to teaching the class in a regular rotation with us.

Though I certainly agree that there could be an excellent course on consciousness in psychology, the course we proposed is a not a psychology course, but a philosophy course. It pursues topics at the intersection of our fields, and the readings are divided pretty evenly between things written by philosophers and by psychologists. But the readings are all selected with an eye to traditional philosophical questions about epistemology, the nature of mental representation, free will, the identity of persons and the metaphysics of mind. And those would be the issues the course lectures and discussion would cover.

So, what do you think? Can psychology concur?

Well, this one is pretty much a psychology course, but since we don't have something that quite spans this topic, I think this course would be a good addition to the undergraduate curriculum. What would you think about cross listing the course as PHILOSOPHY and PSYCH? That would allow a psychologist to teach it on occasion. The way ASC works, the credit for the course goes to whichever course the instructor is from. If this course is taught regularly by someone from Philosophy, your department would get the enrollment credit. We have cross listed courses like this with Linguistics that are mostly taught by linguistics faculty but on occasion are taught by a psychology faculty member.
