# Drugs and Society: SOC 4506

#### **COURSE DESCRIPTION:**

In this class, we will approach the phenomenon of substance use from a sociological perspective. This viewpoint will lead us to examine questions such as why do individuals use drugs, why are some substances criminalized while others are not, what is the relationship between race and class and the adoption and enforcement of drug laws, what effect has the proliferation of drug laws had on the criminal justice system and other social institutions, and how else are drugs approached around the world and what are other potential models of substance control. Throughout, we will watch media portrayals of drugs in news, movies, television, commercials, and music in order to critically examine how drugs are portrayed to the public. In discussions, we will analyze advantages and disadvantages of approaches to each of the above questions from all points on the political spectrum.

**Course Requirements:** There are two exams and four short written assignments for this course.

- 1. Exams: (30% each = 60% of total grade)
  - There will be a midterm and final for this course. The exams will be a combination of multiple choice, true/false, matching, and short answer questions. The midterm is very close to the beginning of Spring Break, please plan accordingly.
- 2. Written assignments: (10% each = 40% of total grade)

There will be four short written assignments of two varieties. The first type will ask you to read one scholarly article on substance use, summarizing and critically analyzing the results in the paper. The second type will ask you to watch two movies from a provided list and critically analyze how substance use is depicted in those movies. No paper should be more than 4 double-spaced pages. The assignments with more specific details will be posted on the class website at least two weeks prior to when they are due.

#### **Policies and Miscellaneous**

- -Attendance is not mandatory. However, you will be highly disadvantaged by missing class. There is valuable information given during lecture that is not in the assigned readings and you are expected to know lecture material for the exams.
- -There is no extra credit in this class.
- -Incomplete coursework is a major inconvenience for students and instructors. You are expected to do everything in your power to avoid this situation. No incompletes will be given unless you have a prior written agreement with the instructor.
- Legitimate reasons for missing an exam include verified illnesses and extremely serious family emergencies. Proper documentation is required to make up an exam. No exams will be given early. No late papers will be accepted.
