On Friday, Oct. 23, the ASC Curriculum Committee reviewed a proposal to revise the Forensic Science Minor.

The Committee unanimously approved the proposal with one question/recommendation:

• The SBS Panel had previously noticed that a course listed on the minor sheet, Molecular Genetics 5640, did not exist in the course catalog and asked the Department of Anthropology if this course should be deleted from the advising sheet.
