There would not be a formal commitment to subsequent thesis advising (although that might be a result, it isn't a guarantee). What I meant to convey was the sense that writing a seminar paper can be a 'gateway': getting some experience with writing a research paper demystifies the process, and latching onto a theme or idea while developing a working rapport with a faculty member might make it more likely a student will pursue an idea in depth through a thesis down the line.

Thank you for the clarification. I've consulted with the faculty member and while he is willing to meet regularly – in his words, "semi-weekly" – with each Honors student individually to consult on a topic and offer guidance throughout the research process, he is not willing to offer, in addition to that, a separate weekly discussion section for those students. His rationale is that his teaching style in the lecture is discursive, leaving much room for Q&A and discussion, and the commitment to individualized advising for a term paper translates to several additional one on one hours for each student. As such, Honors students would have a distinctive discussion, mentoring, and advising experience, one that the other students in the class would not have.

To require that he commit to provide, on top of that, an additional discussion hour would entail about another hour of course prep on top of that. In his view, given the structure of the course and his teaching style, the added pedagogical benefit to the student from this particular practice of group discussion is not sufficient to justify the additional time/prep commitment beyond teaching this as a 75+ student course, managing a TA, and advising all of the individual research papers. His willingness to apply to add an "E" component to the class came out of a willingness and desire to advise on undergraduate research and potentially help students work their way toward graduating with (Honors) Research Distinction. We are working hard to build the research culture in the department, and offering a few "E" courses with top instructors, which can expose students to research opportunities, is one of the strategies through which we are hoping to do so.

If both changes – greater specification regarding paper advising and a dedicated discussion section – are required by the Honors/Scholars Advisory Board in order for us to offer this particular course, then I'm afraid we will have to withdraw the application. However, I'd urge the board to reconsider, since this means that some of our best undergraduate students will not have the opportunity to work with Prof Wendt at all. If the Advisory Board will permit the course to have the research paper component but not the discussion section, then he would be happy to specify the advising process in greater detail in the syllabus. If the Board is willing to consider this latter possibility and needs any additional information, please let me know and I'm happy to talk further.

Thank you for your e-mail message. Any feedback (and perhaps that was the wrong word for me to use in my original e-mail, so I apologize for any confusion it caused) that our Honors & Scholars Faculty Advisory Board offers when we contact departments regarding courses or programs is official in that they expect it to be incorporated into the course for it to be approved for Honors or Embedded status (in other words, in most cases, the committee will not approve the course unless the items are added). At the same time, the committee also recognizes the constraints of the unusually short time-frame of this particular course approval process and understands that there is not the normal time allotted for revisions.

I have consulted with the faculty on our advisory board regarding your e-mail message and how to proceed in this situation. Given the fact that you would like the course to be offered next semester and we are pressed for time, the committee has agreed to go ahead and approve the course so that it can officially be added to the registrar's course listing and students may be enrolled. This approval is made with the understanding that Prof. Wendt will make the changes to the course and syllabus listed below before the start of Spring semester. They have asked me to e-mail you in early January to get the updated syllabus so that this can be put into curriculum.osu.edu website so that the officially approved syllabus is on record. From a technical standpoint, I think that Charles Smith will need to re-submit the course by clicking the appropriate buttons in the on-line system (when we sent it back for changes, it leaves my worklist on curriculum.osu.edu).

Thank you for your note. I agree that weekly hour-long recitations with a faculty member are desirable and also that it would have been helpful for the faculty member to write into the syllabus the steps of research paper writing and the nature of his interaction with students in that process. I will pass along the feedback to Prof Wendt; also, thinking ahead, I will be sure to stipulate both of these to any faculty member willing to propose an "E" version of her or his course.

For now, as I think about enrolling for spring semester 2016, I'm wondering whether you mean these two pieces of feedback as official contingencies, so that students will not be able to enroll in the course until Prof Wendt finds a time for such a weekly meeting and gets in a scheduling /room request (which might make us unable to offer the course for winter at this point) and/or until he specifies on the syllabus precisely how he will advise the project? I hope this is not the case, since I know of 3-4 students who have been eagerly awaiting the opportunity to take this course for Honors credit (Prof Wendt teaches only one undergrad course per year, and so our best undergraduates rarely have the opportunity to take classes with him). But if it is the case then could you let me know relatively soon so we can try to make it happen?
