Ms. Lindeboom,

On Tuesday, February 23, the Arts and Humanities Panel of the ASC Curriculum Committee reconsidered a proposal to add GE Cultures and Ideas to Engineering 5797.18.

The Panel unanimously approved the request with the following 2 comments:

- Form in curriculum.osu.edu: As indicated in the Panel's previous feedback, the subsidy level needs to remain "doctoral" as all 5000-level courses need to be linked to the highest level program in the offering unit ("general studies" is not possible for a 5000-level course). ASCCAO will change this back for the College of Engineering before advancing the course.
- Also as included previously in the Panel's feedback, syllabus should provide GE goals and expected learning outcomes of GE Cultures and Ideas followed by a statement that explains how the course will satisfy the stated GE expected learning outcomes. See p. 14 of ASC Curriculum and Assessment Operations Manual (<http://asccas.osu.edu/sites/asccas.osu.edu/files/asc-curr-assess-operations-manual.pdf>). Request that the proper GE language be included in the syllabus before course is taught next.

I am including a reminder that the GE assessment plan will need to be implemented from the very first offering of the course as a GE course and GE data gathered. As is the case for all new GE courses, after the second offering of the course, the Assessment Panel of the ASC Curriculum Committee will ask the College of Engineering to submit an initial report summarizing GE assessment results of those first two offerings (following the format of sections I and II of the Assessment Report Requirement in Appendix 8 of the ASC Curriculum and Assessment Operations Manual [p. 116] http://asccas.osu.edu/files/ASC_CurrAssess_Operations_Manual.pdf). Our program assistant Danielle Hogle (hogle.12) can help the College with any aspect of the GE assessment requirement. She will also make sure to contact the College of Engineering before the course is offered and provide any assistance that may be needed with assessment. Could you please communicate this information to the faculty member(s)?
