Subject: Psychology 3371 and Linguistics 3701

Ben, Alisa, and Julie,

This week the SBS Panel reconsidered the proposal to offer an on-line version of Psychology 3371/Linguistics 3701, and the Panel e-voted on this proposal.

The proposal was unanimously approved with the following contingencies:

- (a) Include webcam in the section of necessary equipment.
- (b) The syllabus should also state explicitly that students will be monitored while they are taking the online exams.
- (c) For both syllabi:
 - Statement on academic misconduct: Include link to Code of Student Conduct (see ASC Curriculum and Assessment Operations Manual p. 14, if necessary). Also, link to COAM is outdated.
 - Statement about disability services: Add link to ODS website (see ASC Curriculum and Assessment Operations Manual p. 14, if necessary). Please note that the on-line syllabus includes link to ADA website. That is usually not included.
 - Remove reference to "GEC" and replace with "GE." (In-class syllabus: p. 1; on-line syllabus: bottom of p. 4). Indeed, the "GEC" has not been used since before semester conversion (2012). Furthermore, the syllabus should mention the subcategory of the Social Science GE. In short, the heading for that section on each syllabus should say, "GE Info: Social Science-Individuals and Groups."

I will return both courses via curriculum.osu.edu in a minute to enable the departments to address the points above.
