Dear Curtis,

Professor Janice Aski (Chair of the Arts and Humanities Panel) has looked over the revised submission for AAAS 4342 and has approved the course. The course will now be advanced to the Office of Academic Affairs and the Office of the University Registrar.

That said, in her feedback Janice indicates that the GE assessment plan may still contain potential issues. For example, when the plan is implemented, the methods of assessment will need to assess each GE expected learning outcome individually, and assessment reports require one to provide separate data for each GE expected learning outcome. Also, in most cases, assignment grades are not acceptable measures to evaluate student achievement of GE expected learning outcomes. Therefore, we do recommend that the faculty member in charge of the course contact our program assistant Danielle Hogle (here cc'd) before the course is taught to make sure that the assessment requirements are fully understood. Danielle Hogle works for our office and (in collaboration with the faculty Panel in charge of assessment) provides support to units with GE assessment reporting requirements. It would be very good that the faculty member work with her since the course's GE assessment plan will need to be implemented from the very first offering of the course and GE data gathered. After the second offering of the course, the Assessment Panel will ask AAAS to submit an initial report summarizing GE assessment results of those first two offerings (following the format of sections I and II of the Assessment Report Requirement in Appendix 8 of the ASC Curriculum and Assessment Operations Manual [p. 116]

On Tuesday, March 29, the Arts and Humanities Panel of the ASC Curriculum Committee reviewed a proposal for a new course AAAS 4342 with GE Cultures and Ideas and GE Diversity-Global Studies.

The Panel approved the course with the following contingencies:

The current plan presents many different ways to potentially assess the GE categories but (1) the multiplicity of options does not make this an implementable plan and (2) the plan does not tie methods to the specific GE expected learning outcomes.
