Dear Professor Cherry,

The ASC Curriculum Committee has reviewed your proposal for a new freshman seminar, "The Rhetoric of Election 2016."

I am happy to report that the proposal was approved with three recommendations:

- Please inform the Dept of Political Science (Richard Herrmann, Chair; herrmann.1@osu.edu) and the John Glenn College (Robert Greenbaum, Associate Dean for Curriculum; greenbaum.3@osu.edu) about this new freshman seminar.
- Single term 1-credit courses should meet twice a week for 55 minutes for 7 weeks. Please know that your syllabus refers to two meetings of 70 minutes for 7 weeks. This should be corrected.
- It is recommended that you use the official ASC-approved statement on academic misconduct and the statement about disability services (recommended 16 pt font) as found here <http://ascas.osu.edu/curriculum/asc-syllabus-elements>

In other words:

- "It is the responsibility of the Committee on Academic Misconduct to investigate or establish procedures for the investigation of all reported cases of student academic misconduct. The term "academic misconduct" includes all forms of student academic misconduct wherever committed; illustrated by, but not limited to, cases of plagiarism and dishonest practices in connection with examinations. Instructors shall report all instances of alleged academic misconduct to the committee (Faculty Rule 3335-5-487). For additional information, see the Code of Student Conduct <http://studentlife.osu.edu/csc/>."
- "Students with disabilities that have been certified by the Office for Disability Services will be appropriately accommodated and should inform the instructor as soon as possible of their needs. The Office for Disability Services is located in 150 Pomerene Hall, 1760 Neil Avenue; telephone 292-3307, TDD 292-0901; <http://www.ods.ohio-state.edu/>."
