Thank you again for the resubmission. I am happy to report that it was approved with a few suggestions:

- Students might not be receptive to the statement about the role of students in stimulating discussion.
- Suggestion to further define how grade for participation will be assessed. Only expected (minimum) level has been stipulated, which seems more like S/U. Students will be freshmen, non-Honors, and they may not be prepared for appropriate levels or styles of participation right-out-of-the-gate. Consequence of non-attendance (drop in participation grade, failure, etc.) should be identified.
- · Final version of syllabus will need to contain details about paper length, further information about topic, and timeline.
- · Final version of syllabus will need to contain grading scale.
- It is recommended that the statement about disability services appear in 16 pt font on the syllabus.

Will there be a way for students to access the readings without purchasing all of the books? If not, that may keep students from registering. A related concern is that the amount of readings may be too much
