We received a revision to the 100% on-line request for CSFRST 2374 (an existing course with GE Historical Study). Janice Aski, the Chair of the A&H1 Panel, has asked that the course request be advanced but sees some lingering issues with the GE assessment plan. Some of the problems include: (1) the information is not quantifiable and (2) an entire quiz or exam does not measure the GE expected learning outcomes, so grades on these elements of the course cannot be used for GE assessment. On Tuesday, October 25, the Arts and Humanities 1 Panel of the ASC Curriculum Committee considered proposals to offer CSFRST 2374, KNSISM 2210, and KNSISM 2211 (all existing courses with GE Historical Study) 100% on-line.

CSFRST 2374: Approved with one contingency and two questions/recommendations

- Contingency: For the panel to be able to ascertain the distance delivery of the GE
 Historical Study, please submit a GE assessment plan adapted to the distance
 learning environment.
- Questions/recommendations:
 - o How many people are expected in this course? 299 students are in the face-to-face version. How will you manage on-line discussions/feedback?
 - o Some of the items in the response to the Panel refer to actions/measures that will be taken when the course is taught. Why not incorporate these in the actual syllabus submitted for review?

KNSISM 2210 and KNSISM 2211: The Panel did not take a vote but would like the following points addressed first:

- What are the expectations for online discussions (beyond being civil)? How does instructor moderate the discussions?
- For the panel to be able to ascertain the distance delivery of the GE Historical Study, please submit a GE assessment plan adapted to the distance learning environment.
- In both the in-class and the on-line syllabi, please use the most recently updated GE language. The submitted syllabi include pre-semester GEC language. With semesters, the university switched to the GE (so "GEC" should no longer be used) and the current goals and expected learning outcomes for GE Historical Study courses are:

Goals:

Students recognize how past events are studied and how they influence today's society and the human condition.

Expected Learning Outcomes:

- 1. Students construct an integrated perspective on history and the factors that shape human activity.
- 2. Students describe and analyze the origins and nature of contemporary issues.
- 3. Students speak and write critically about primary and secondary historical sources by examining diverse interpretations of past events and ideas in their historical contexts.
- For both on-line syllabi, please update the physical address of the Office of Student Life Disability Services (098 Baker Hall).
