On Friday, September 16, the Arts and Humanities 2 Panel of the ASC Curriculum Committee considered twin proposals to (1) add GE Diversity-Social Diversity in the US to Comparative Studies 2214 and cross-list the course with Sexuality Studies 2214 & (2) create new course Sexuality Studies 2214 (with GE Diversity-Social Diversity in the US; cross-listed with its Comp Studies equivalent).

I am happy to report that the course requests were unanimously approved with two recommendations/comments:

- Syllabus p. 1 should also state the GE goals (namely: "Students understand the pluralistic nature of institutions, society, and culture in the United States and across the world in order to become educated, productive, and principled citizens."), not only the GE expected learning outcomes.
- Last page of assessment plan refers to Tracdat. Please know that Tracdat will not be used for

GE assessment. GE reports are currently still being submitted via e-mail. Eventually, Qualtrics will likely be used for GE assessment reporting purposes.

The courses will now be advanced in <u>curriculum.osu.edu</u>.
