On Wednesday, September 21, the SBS Panel of the ASC Curriculum Committee considered new course requests for Political Science 3290 & 3310.

Please find below the feedback of the Panel:

- <u>Political Science 3290</u>: unanimously approved with two recommendations:
  - P. 4 of syllabus: How does reducing the grade of an assignment by 1/3 of a grade each day that this assignment is late translate in terms of the percentages used for the assignments? The Panel can think of three different ways this could be interpreted. Clarify what the intention is.

Remove discussion question from last page of schedule.

- <u>Political Science 3310</u>: unanimously approved with one comment and two contingencies:
  - <u>Comment</u>: Political Science 3310H also appears in the curriculum map and a concurrence from International Studies for Political Science 3310H has been uploaded on the course site for PS 3310 (together with the concurrence for the non-H course). Panel notices that Political Science 3310H has not been submitted yet. (After the meeting, ASC Curriculum and Assessment Services double-checked status of the H version and noticed it is still at the initiator level in the Department.)
  - <u>Contingencies</u>:
    - Schedule indicates that on 4/19, the wargame reports are due. What are the wargame reports? These are not explained in the course assessment section.
    - Please include contact hours on the syllabus.

Political Science 3290 will now continue through the approval process. As for Political Science 3310, I will return the course via <u>curriculum.osu.edu</u> in a minute to enable the department to address the points above.
