On Wednesday, November 2nd, the ASCC NMS Panel reviewed the revised proposal for Biology 1110 and I am happy to report that the Panel *unanimously approved* the revisions made.

The course will now continue through the approval process.

I am also including a reminder that the GE assessment plan will need to be implemented from the very first offering of the course and GE data gathered. As is the case for all new GE courses, after the second offering of the course, the Assessment Panel of the ASC Curriculum Committee will ask the department to submit an initial report summarizing GE assessment results of those first two offerings (following the format of sections I and II of the Assessment Report Requirement in Appendix 9 of the ASC Curriculum and Assessment Operations Manual [p. 121]

- Clarify if this GE course is for BA-students only or designed for both BA and BS students. If the unit wants this to fulfill the GE requirement for BA and BS students then please provide an explanation (see criteria for BA/BS GE Natural Science courses on page 65 of the ASC Curriculum and Assessment operations manual: http://asccas.osu.edu/sites/asccas.osu.edu/files/ASC_CurrAssess_Operations_Manual.pdf)
- Provide specific examples of the methods used for GE assessment (i.e. questions that will be used on exams or quizzes that are aligned to the GE expected learning outcomes).
