This note to let you know that Richard Fletcher approved the revisions to your dept's request to add GE Diversity-Social Diversity in the U.S. to Religious Studies 3678 and the course request will now move forward to OAA/OUR.

The Assessment Panel and/or our office can help the department with any aspect of the GE assessment requirement. Dear Barry and Elizabeth,

On Friday, January 20, the Arts and Humanities 2 Panel of the ASC Curriculum Committee considered a proposal to add GE Diversity-Social Diversity in the U.S. to Religious Studies 3678.

The Panel unanimously approved the course with one contingency about the GE assessment plan and two recommendations:

- Contingency: GE assessment plan:
  - For each assessment method you will use, please provide specific examples of questions.
  - For the longer paper assignments, “rubrics” are mentioned. Please provide sample rubric.
  - How will you assess “semester-long” discussion? How will faculty member be able to assess discussion throughout the semester? More focused assessment method would be preferable.
  
- Recommendations:
  - The Office of Student Life Disability Services has moved and the College’s preferred statement is now, “Students with disabilities (including mental health, chronic or temporary medical conditions) that have been certified by the Office of Student Life Disability Services will be appropriately accommodated and should inform the instructor as soon as possible of their needs.
