On Friday, March 10, the Arts and Humanities 1 Panel of the ASC Curriculum Committee reconsidered a proposal to add GE Historical Study to Public Affairs 2500.

The Panel unanimously approved the request with one contingency and one recommendation:

- Contingency: Please provide a GE assessment plan. The assessment plan provided is not specific to GE Expected Learning Outcomes (ELOs). Assessing students is not the same as GE assessment. See pp. 51-53 in ASC Curriculum and Assessment Operations Manual <a href="https://asccas.osu.edu/sites/asccas.osu.edu/files/ASC CurrAssess">https://asccas.osu.edu/sites/asccas.osu.edu/files/ASC CurrAssess</a> Operations Manual.pdf
- Recommendation: The panel recommends making primary sources stand out more in the syllabus and making sure that students understand the importance of primary sources.
