Enclosed for your review is a proposal for the creation of dual degrees between 1) the M.A. in Public Affairs and the M.A. in Women's, Gender and Sexuality Studies and 2) the M.P.A. in Public Affairs and the M.A. in Women's, Gender and Sexuality Studies (WGSST), which I am pleased to endorse. These dual degrees will promote the interests of both the Glenn College and the Department of Women's, Gender and Sexuality Studies and serve the overall mission of the University. The proposal was unanimously approved by the Glenn School's Graduate Studies Committee on 10/5/16.

In short, for those students who qualify for the In-Career Masters of Public Policy and Administration, a dual MA-MA with Women's, Gender and Sexuality Studies would total 53 credits (35 cr. JGC/ min. 15 cr. WGSST). For students qualified to pursue the MPA, 67 credits of coursework would be in order (37 JGC/ min. 15 cr. WGSST / min 15 cr. Electives in either unit). We anticipate that most students would be pursuing the MPA option.

Proposal to Create Dual Degrees between the John Glenn College and the Department of Women's, Gender and Sexuality Studies (MA/MA and MPA/MA)

Introduction

The John Glenn College of Public Affairs (Glenn College) and the Department of Women's, Gender and Sexuality Studies (WGSS) propose to create two dual Master's degrees: 1) a Master of Public Administration (MPA) and Master of Arts (MA) in Women's, Gender and Sexuality Studies; and 2) a Master of Arts (MA) in Public Policy and Management and Master of Arts (MA) in Women's, Gender and Sexuality Studies.

The proposed dual degree seeks to promote the interests of both units and to serve the mission of the Ohio State University. The proposed dual degrees will:

- Add to our ability to prepare students for careers in the public sector, public policy and international service, utilizing existing resources at the University without a significant increase in resources (such as new faculty) and courses;
- Allow the Glenn College to add gender, race, sexuality and disability content to elective and capstone classes currently offered in order to incorporate broader areas of their research interest and expertise, which will further enrich the School's existing curriculum;
- Increase the attractiveness of the degree program to a new student population. Master's students in WGSS are often interested in nonprofit work and public policy and will be able to obtain a wide range of employment with the dual degree (e.g., working with NGOs and a variety of national, state and local agencies);
- Contribute to the University and College's objective of fostering interdisciplinary curricular options and research; and
- Enhance diversity in both units' student populations in terms of backgrounds, perspectives, skills and knowledge that students would bring into our respective programs.

For The Ohio State University, the degree will:

- Contribute to the University's desire to foster interdisciplinary curricular options;
- Strengthen two academic units by expanding the capacity for each without adding additional resources; and
- Enhance curricular offerings for graduate students throughout the University.

Admissions Policies

Students may either apply to both programs when applying to graduate school or to one program, and then once matriculated, complete the application process for the other program. Students applying for the MA-WGSS will be held to standard admissions policies and processes as dictated by the department. Students applying to either the MPA or the MA-JGC as a dual degree option will be held to the standard admissions policies and processes as dictated by the Glenn College for admission to the appropriate program. The difference is in the credits

required for the dual degree (see breakdown below) and in the name of the degree stated on the transcript. If a student applies to the MA-JGC program who meets the “In-Career” degree admission requirements (see <http://glenn.osu.edu/graduate/admissions/checklist/>), s/he may apply as an “In-Career” MA student and will be held to the admissions standards for the “In-Career” MA degree.

Degree Requirements

For either dual degree option (MA/MA or MPA/MA), all coursework that is to count toward degree requirements must be graded (“A-E” or “S/U”) graduate-level coursework at the 5000-level or above. Students have two options for pursuing a dual degree with Women’s, Gender and Sexuality Studies and the John Glenn College of Public Affairs as outlined below.

1. MA-WGSS/MA-JGC – 53 Credits

Taken separately, the MA-WGSS is comprised of 30 semester credit hours and the MA in Public Policy and Management is 38 credit hours. The dual degree requires a minimum of 15 credits from WGSS, and a minimum of 35 credits from the John Glenn College, for a total of 53 credit hours. The structure of the MA-WGSS is the same within both dual degree plans. The following description of the MA-WGSS within the dual degree is repeated in section two.

MA students are required to take the capstone course in the semester in which they intend to graduate. An overall grade of “B” or higher is required for the capstone course to count as your MA exit requirement. In addition, as part of the exit requirement set forth by the Graduate School for students earning Master’s degrees an exit assessment will be conducted as a part of all capstone courses. 2. MA-WGSS/MPA - 67 credits

Taken separately, the MA-WGSS is 30 credit hours and the Masters of Public Administration (MPA) is 52 credit hours. The dual degree requires a minimum of 15 credits from WGSS, and a minimum of 37 credits from the John Glenn College, and an additional 15 credit hours of approved elective coursework, for a total of 67 credit hours. [This averages 13.4 credits for 5 semesters, making this very feasibly a 2-year plan.]
