Dear Trevon and Ana,

Thank you for submitting a revision for the Quantitative Economics Minor proposal. I have submitted the revision to Christina Roup & she has indicated that all the contingencies listed in the email below have been addressed satisfactorily.

That said, when the department revised the minor advising sheet, a few mistakes were inserted. These should be addressed as well:

- Under option 1, for Economics 4001 and 4002, please remove 4001.01 and 4002.01 (because these cannot be taken under option 1)
- At the bottom of the left column, it says "Statistics Prerequisites for (3-4 credit hours)". Please should include "*for Economics 5410*" so students are clear what course the prerequisites are for.
- Please remove the math prerequisites because (1) it is unclear if they are for the whole minor, (2) the list of prereqs is incomplete, and (3) some students reading this might think they have to take all the courses (since there is no "or" to separate those courses).

I will return the proposal one more time to enable the department to make the necessary changes to the advising sheet.

Dear Trevon and Ana,

On Friday, September 15, the SBS Panel of the ASC Curriculum Committee considered the proposal for a new Quantitative Economics Minor.

The Panel unanimously approved the proposal with a few contingencies listed below:

- Include projected student enrollment in proposal (number of students unit anticipates will take the minor and what program they may come from).
- P. 1: Next to last line: Econ “542” should be 5420.
- P. 2: Minor cannot begin Autumn 2017. Please adjust.
- Further explain the two options (flesh out) in proposal (p. 2) and on advising sheet.
- P. 4: “Transfer and EM credit would be allowed with no more than one half of the credit hours coming from non-OSU credit. No course that counts within a major can be used for the minor.” These statements are incorrect (and contradict the correct information on the advising sheet). The correct language is: A student is permitted to count up to 6 total hours of transfer credit and/or credit by examination. (One cannot say “one half of the credit hours” because that would be 7.5 hours for this minor.) Any hours above 12 credits can actually overlap with a major or another minor.
- Advising sheet:
 - Right column states the minor is 15 to 17 credit hours, whereas left column states that the minor consists of 15 to 16 credit hours. The Panel believes that 15-16 is likely the correct information, but the Dept of Economics should check the information and correct the advising sheet.
 - Add prereqs for Econ 5410 on advising sheet. (Indeed, students taking Option 2 in the minor are not likely to have taken the Stats prereqs for 5410 & these Stats prereqs have their own prereqs.)
 - Bottom of page: Address of Denney Hall changed to 164 Annie & John Glenn Ave. (No longer W. 17th Ave.)
- List of concurrences: Trevor Brown should be “Trevor.”

I will return the proposal via curriculum.osu.edu to enable the department to address the points above.
