Dear Dana,

The attached course has been reviewed by the Arts and Humanities Curricular Panel as part of regular curricular review process. Given that it treats French history and culture, and given that an education abroad course taught by Danielle Marx-Scouras has been offered 2 times now – also travelling to France and southern France, it seems that concurrence from FRIT would be a good expected.

I'm including Professor Alice Conklin on this message for assurance. While the attached course also tangentially considers topics covered in Professor Marx-Scouras's course, I believe that both courses serve the university well and serve the university differently. In that light, I seek your department's concurrence.

Please know that that:

- History would not offer this course in the same term that FRIT offered the course currently approved and instructed by Professor Marx-Scouras.
- Furthermore, History would always coordinate with FRIT in any future offering of the History course, and consider cross-listing if that was appropriate.
- The attached course was specially designed to appeal to and recruit students in Pell eligible programs (with high economic need) and participating in ODI-scholars programs or the ASC PASS scholars program exclusively.
- Professor Conklin's course is open to ODI and PASS Scholars for SU18 only at this point. If FRIT offers a course addressing France beyond borders in SU 19, then Professor Conklin's course would either not run, or postpone. It would make no sense to offer 2 courses in the same regions in France at the same time. Professor Conklin's course has been developed and priced to specifically address the lack of diverse participation in education abroad across the university and has no intention of competing with any other university abroad program.
- Simply put, I think that FRIT can only benefit from Professor Conklin's course and her expertise in French history in order to further a view to mutual collaboration in education abroad courses that encourage interest in French diversity.

Let me know if you or your faculty have any concerns. Please advise within 2 weeks. No response indicates that concurrence is assumed. An email response is sufficient and if there are any concerns, please let us know.
