The Panel did not vote on the course but would like the following points addressed first:

- Please provide information regarding the overlap with the existing first-year seminar "Famous Voices." Clarify the need for two separate but very similar courses. Will students who have taken the first-year seminar be excluded from taking Linguistics 1101? If not, the courses are too similar to co-exist and one should be withdrawn.
- Please request concurrence from the Department of Speech and Hearing Science.
