On Tuesday, December 5, the Arts and Humanities 1 Panel of the ASC Curriculum Committee reviewed a new course request for Pharmacy 3530 (with GE Cultures and Ideas).

The panel was impressed by the quality of the proposed course. Everyone thought the topic sounded very interesting. The Panel voted to approve the GE request with one contingency and two comments.

- Contingency: GE assessment plan: Please provide at least one specific example of question for the final short writing assignment that will assess both ELO 1 and 2.
- Comments:
 - Inconsistency about title: The form in curriculum.osu.edu reads “Drug Human Enhancement and Mastery of Nature.” However, the title on the syllabus reads, “Drugs, Human Enhancement, and the Mastery of Nature.” Please reconcile.
 - P. 3 of syllabus: Attendance: “. . . more than 2 absences will cost you points on your participation grade” How many points are deducted per absence?

I will return the course request via curriculum.osu.edu in a minute to enable the College of Pharmacy to address the Panel’s feedback.
