I apologize for the delay in making the suggested improvements. I was in Tijuana last week for my education abroad program, and had limited access to internet.

I have attached an updated syllabus. I would also like to address the comments based on their order in your email.

- 1) I added a specific point loss for missed classes.
- 2) I corrected the course title to ASC 1137
- 3) I have not provided page numbers. Textbook chapter readings will be suggested and not mandatory. I may change some articles before fall semester if I find more recent or better articles to fit with the themes, but I will keep the concern on reading load in mind. Article length is not always a good indicator of time required to read and understand, but again, I will focus on keeping the reading assignments consistent with a one hour seminar course.

4) I have removed the country presentation and final exam from the course. The grade will be based on the weekly discussions and reflections. I still plan to follow up with Mat to discuss his experience, and I have already discussed my proposed seminar with my colleague, Ethan Doetsch.

Thanks so much for your input. I am very excited to teach this! I am happy to make any additional adjustments that the committee deems necessary.

Dear Darcy (if I may),

On Tuesday, March 6, the Social and Behavioral Sciences Panel of the ASC Curriculum Committee reviewed your proposal for a new first-year seminar, "Nom-nomics: The Economics of Food."

The Panel unanimously approved the proposed seminar with one contingency and four comments/recommendations:

- <u>Contingency</u>: P. 2 What does the following mean? "More than two missed classes will result in a significant point loss for participation." Provide more specifics.
- Comments/recommendations:
 - P. 1 of syllabus: This should be ASC 1137, not Econ 1137.
 - Providing page numbers for the readings would be helpful. (Also for the Panel it is hard to gauge reading load when no page numbers are provided.)
 - The Panel members recommend removing the country presentation and the final exam so as to reduce the course load. Mat Coleman, a faculty member in the Department of Geography and a member of the SBS Panel, is available to chat about his experience teaching a first-year seminar.
 - If you decide to keep the country presentation assignment, the Panel wishes to point out the contradiction in the syllabus that most of the readings are about the US.
