Dear Professor Skinner,

On Monday, April 30, the Arts and Humanities 2 Panel of the ASC Curriculum Committee reviewed a course change proposal for AAAS 2270.

The Panel unanimously approved the request with the following recommendations:

- Change typo on page 3 of the syllabus referencing quarters (under point 1 in the "Course Requirements" section).
- Panel was unclear what the "three hourly tests" are. Should this be "three hour long tests?" Panel recommends rewording this in the syllabus to clarify for students.
- Give more detail on assignments in the syllabus. Clarifying the nature of the assignments and showing how they relate to the GE, particularly GE VPA, will strengthen the rationale for the course as a GE VPA.

Additionally, the form on curriculum.osu.edu does not indicate the addition of the two GE categories to the course. We cannot change this at our level, so I will return the course to you to add the GE categories before the course can continue through the approval process.
