The situation here is somewhat different, since 5321 has never been offered. I have included the syllabus used to create the course originally. This earlier material has been covered as introductory material in 5322. The change to 5322 requested is effectively only a change in the title to correctly reflect the material covered.

What is the rationale for the proposed change(s)?

Upon conversion to semesters, a four-course curriculum was created in Ancient Greek & Roman Art & Archaeology courses at the upper (5000) level. Since then, it has become apparent that a simplified, two-course curriculum is both more practical, given that only one current faculty member teaches these courses, and better serves the students in the courses, who are nearly all undergraduates. Defined this way, each course provides a complete overview of art and archaeology of one of the Classical civilizations, yet each is sufficiently focused as to provide for students to explore works of primary scholarship and consider controversies and methodologies in each field. Moreover, the two courses, even with only one available instructor, can be cycled regularly and predictably, so students in History of Art, Classics, History and related disciplines can include them in their long-term curricular planning. Normally 5311 would be offered in the Autumn and 5322 in the Spring, providing a year

I. Course Objectives

This course will explore the art history, archaeology, and material culture of the Hellenistic Mediterranean and Roman Republic (ca. 350-27 BCE). Students will be encouraged both to consider the wide range of disciplines that contribute to the field of Classical Archaeology, including such sources of evidence as material remains, inscriptions, and literature, and to apply the methodologies of art history, archaeology, anthropology, history and philology.

II. Course Requirements

A. Examinations

There will be **one midterm examination** on **XXX**. This will include some or all of the following: slide discussions, slide comparisons, essay questions.

COURSE CHANGES IN HISTORY OF ART/CLASSICS COURSES AT 5000-LEVEL

RATIONALE:

Upon conversion to semesters, a four-course curriculum was created in Ancient Greek & Roman Art & Archaeology courses at the upper (5000) level. Since then, it has become apparent that a simplified, two-course curriculum is both more practical, given that only one current faculty member teaches these courses, and better serves the students in the courses, who are nearly all undergraduates. Defined this way, each course provides a complete overview of art and archaeology of one of the Classical civilizations, yet each is sufficiently focused as to provide for students to explore works of primary scholarship and consider controversies and methodologies in each field. Moreover, the two courses, even with only one available instructor, can be cycled regularly and predictably, so students in History of Art, Classics, History and related disciplines can include them in their long-term curricular planning. Normally 5311 would be offered in the Autumn and 5322 in the Spring, providing a year-long coverage of the art and archaeology of the Classical world.

At the same time, we are seeking to withdraw the Classics versions of these courses and Classics 4301 (Ancient Greek and Roman Art). These were created only for the purposes of cross-listing these courses. These create additional work for staff, have not been well-enrolled, and students can easily enroll using the History of Art number; in fact, many Classics students do so already.

CHANGES REQUESTED-

 HA 5311 - Withdraw HA 5312 - Change as indicated by syllabus

The material from these two classes, from the Bronze Age through the Classical and Hellenistic Periods, is combined in the proposed amended 5312. The sequence as intended was not as successful as hoped because very few students were able to fit both courses into their schedules, and thus most were able to study only a portion of the time period.

I have appended actual syllabi from both HA/CL 5311 and 5312 as well as an amended proposed syllabus for HA 5312 (Art and Archaeology of Ancient Greece)

HA 5321 - WithdrawHA 5322 - Change as indicated by syllabus

The situation here is somewhat different, since 5321 has never been offered. I have included the syllabus used to create the course originally. This earlier material has been covered as introductory material in 5322. The change to 5322 requested is effectively only a change in the title to correctly reflect the material covered.
