On Friday, September 27, the Social and Behavioral Sciences Panel of the ASC Curriculum Committee (ASCC) reviewed a proposal for new course Economics 4797.02.

The Panel unanimously approved the course with three contingencies and one recommendation, which I here list:

- Contingencies:
 - P. 2: Please include further discussion of the different components students are graded on: including a discussion of the exams, an explanation of the class quizzes, individual and group reflection papers, and a further breakdown of the percentages for each of the aspects that make up the 20% attendance grade.
 - P. 3: Grading Scheme: The "OSU minimum guaranteed grades" phrasing is confusing and also in actuality there is no standard grading scheme at OSU.
 Please clarify this statement and provide the grading scale.
 - Pp. 5-6: Schedule: The syllabus needs to include the travel schedule and specific locations and times for the activities.
- Recommendation:
 - When creating the student version of the syllabus, include office hours and due dates for assignments.

I will return Economics 4797.02 via curriculum.osu.edu in a moment so that the department can address the feedback of the Panel.
