I hope you are both well & taking care of yourselves. As you likely know, panels and committees are continuing operating in a virtual environment these days.

The SBS panel recently reconsidered a proposal to renumber Psychology 1200 (an existing course with GE Social Science-Individuals and Groups & Diversity—Social Diversity in the U.S.) to become Psychology 2500. The panel unanimously approved the request with two recommendations:

The revised version of this course removes the recitation. However, note that there are residual references to lab/recitation sessions in the most recent syllabus. These will need to be removed.

- Course Requirements: (1) Exams (60% of the final grade): "Questions may be drawn from material covered in the lectures, material in the assigned readings, and **material in the recitation class**."
- GE Expected Learning Outcomes (Diversity): "Through the lectures and more extensively through the **lab/recitation activities** students will be asked to adopt multiple perspectives on societal institutions and practices, including perspectives different from their own."
- GE Expected Learning Outcomes (Social Sciences- Individuals & Groups): "Students will learn how Psychologists gain knowledge through scientific inquiry and will gain personal experience with this process through the "Research Experience Program" portion of the course and the lab/recitation activities."

The syllabus states that there are three Diversity ELOs and four Social Science ELOs. For each GE category, the first item is actually a GE Goal, not a GE ELO. Thus, there are two Diversity ELOs and three Social Science ELOs.

Could you please let the faculty teaching the course know?

I have already advanced the course request to the next level.
