Dear Professors Williams and Soave,

Recently, the Arts and Humanities 1 Panel of the ASC Curriculum Committee reviewed a new course proposal for ASC 5798 "Ohio State ArTs 2U".

The Panel unanimously approved the request with four contingencies:

- The Panel would like more information regarding how the course will be evaluated. How will a “positive contribution to the group” and “representation of self, school, and country” be measured? Attendance counts for 50% of the grade, but there is no attendance policy.
- There are some discrepancies on how many credit hours this offering will be. The first page of the syllabus says it is variable 1-3 credit hours, the OIA form indicates it will be variable from 0-3 credit hours, and the credit hour rationale says it will be 3 credit hours. Additionally, the credit-hour rationale is not very detailed. The credit-hour rationale should include and explanation of time spent on formalized instruction, structured education experience, and informal time in the country.
- Update academic misconduct statement on the syllabus. The links to OAA appear to be broken.
- Update disability and mental health statements. Updated versions of these statements can be found on page 14 of the Curriculum and Assessment Operations Manual

Please feel free to send a revised proposal to me, and I will then submit it for final approval.
