Please find enclosed a proposal for a new undergraduate minor in **Women, Gender and Public Policy**. The new program will be a dual minor, designed and administered by the John Glenn College of Public Affairs, and the department of Women's, Gender and Sexuality Studies. Advising for the minor will be provided by the Glenn College Student Services team. The Glenn College has several faculty and staff members focusing on the intersectionality of women and policy, including an affiliated faculty member with Women's, Gender and Sexuality Studies; and is also home to Programs for Ohio Women Empowered to Represent (POWER). As a result, the College is in an ideal position to offer this minor.

This proposed minor will provide students across the campus a unique curriculum to study public policy impacting women and to situate feminist perspectives for creating and implementing public policies. Students engaged in this minor will gain a critical assessment of gender, race and sexuality in public life.

The Women, Gender and Public Policy minor is designed to complement other studies from across the university. As a dual minor, the coursework for this program has been created in cooperation with the department of Women's, Gender and Sexuality Studies. In addition, we anticipate that a large number of students from across campus may be interested in this minor as well. The program adheres to university standards for minors, while giving students ample flexibility to take courses that relate to an area of policy of most interest to them. In closing, we thank the committee for their investment of time to review this request and welcome any feedback.

# Proposal Submission for Women, Gender and Public Policy Minor

A new dual minor offered by the John Glenn College of Public Affairs and the Department of Women's, Gender and Sexuality Studies

## 1. Required Information

- Name of proposed minor: Women, Gender and Public Policy Minor
- Proposed implementation date: Autumn 2020
- Academic units: Women's, Gender and Sexuality Studies (ASC) and the John Glenn College of Public Affairs

## 2. Rationale

- The minor will offer undergraduate students a unique opportunity to study public policy impacting women and to situate feminist perspectives for creating and implementing public policies aimed at improving their lives. A core aspect of the minor will be to illustrate to students that the gender category of "women" is intersectional with race-ethnicity, class, sexuality, dis/ability, and geographic location. Ohio State is able to offer this minor by merging existing resources of the John Glenn College of Public Affairs with curriculum in WGSS that focuses on policy, governance, women's diverse identities, social justice initiatives, and social movements. This minor grows out of previous collaborations of WGSS and the John Glenn College such as the New Leadership Program and the current use by the Glenn College and its students of the WGSS minor as a specialization area.
- This minor will offer students an understanding of women's roles in public life; their modes of engaging and leading public affairs; and the gendering of major societal institutions. Students engaged in this minor will gain a critical assessment of gender, race and sexuality in public life.
- The minor teaches students to consider the role of women in policy-making and the opportunity to closely examine how gender identity and uneven and disparate power relations (of gender, sexuality, race, disability, and location) affect different people and communities. The minor will consider differing experiences with and perspectives on public policy and public affairs among women, so that students gain an understanding of

how women's unique positions and embodiments – their intersectionality – situate them in public policy fields and among their communities.

- After completing this minor, students will be able to engage and draft policies targeting women. More broadly, students will be equipped to center gender in their thinking, writing, and discussions on public policy. It is imperative that OSU begin offering a minor that could stand at the forefront of innovative, inclusive, and dynamic public policy.
- The collaborative effort of the John Glenn College and the WGSS Department models the interdisciplinarity OSU seeks in cross-departmental, cross-divisional, and cross-unit projects. This minor will serve a wide range of students who seek careers or further study in electoral politics, non-profit management and leadership, non-governmental organizations, social justice organizations, think tanks, law, nursing, medicine, education, academia, and numerous other areas. Finally, this minor will appeal to the growing number of women with political aspirations, including those who will seek city, state, or federal government and policy careers, either as elected or appointed officials.
- Graduates with this minor will be suited to engage careers in public policy that address policy areas disproportionately impacting women's lives as well as offering them tools to build more inclusive spaces for public engagement of policy. This program will strengthen both academic units by expanding the capacity for each without adding additional resources.

### 3. Relationship to other programs

- Relationship of new minor to existing majors/minors in units:
  - Women's, Gender and Sexuality Studies now offers both a BA major and a minor. The John Glenn College of Public Affairs offers a BA in Public Management, Leadership and Policy; a BS in Public Policy Analysis; and minors in Nonprofit Management; Science, Engineering, and Public Policy; and Public Policy. The new Women, Gender and Public Policy minor will include some WGSS classes and some John Glenn classes. WGSST majors and other majors outside of the John Glenn College must take PUBAFRS 2110 as their required course. John Glenn College majors must take WGSST 2550 as their required course.
- Overlaps with other programs or departments.
  - There are cross listed courses between WGSS and Political Science (WGSS 4513 & 4597), though the content of the minor is not equivalent to a political science minor. The new minor emphasizes a feminist analysis of women and gender in public policy. Cross listed class, regardless of department of offering, are automatically approved to count toward the minor.

### 4. Student enrollment

- We expect student enrollment in the minor to be 25 per year.

## 5. Curricular requirements

- Required courses for students include both the introductory course in WGSS, “Gender, Sex, and Power” (WGSST 1110) and PUBAFRS’s, “Introduction to Public Affairs,” (PUBAFRS 2110). Both of these courses introduce students to the core elements of these respective interdisciplinary fields of inquiry. In the instance that a student is a John Glenn College major, the student will take WGSST 2550: History of Feminist Thought as a replacement of PUBAFRS 2110 as this course must count towards their major and cannot be counted towards the minor.
- To complete the minor, students must also take **THREE** electives ranging from courses on public service and poverty and inequality to global sexual economies and gender and democracy. Of the three electives, students will be strongly advised to take at least one course that explicitly centers intersectional analysis. These courses will enrich students’ understanding of marginalization, inequality, and disparities.
- Courses listed as requirements and as elective options are regularly offered by both academic units. Students will have no difficulty enrolling in courses to fulfill the requirements for completion.
