1. Provide the rationale for proposing this course:

This course fills a major gap in our curriculum in the sociology of sexuality, and we have a new Assistant Professor (Lianna Sayer) who specializes in this area. Importantly, this course is focused on sociological approaches. We examined all of the course descriptions for course offerings in the Sexuality Studies Minor. There are few similarities between Sociology 340 and the other courses. Some courses integrate sexuality in relation to science. Others discuss the deviant aspects of sexuality. Generally, the only common aspects we found between other sexuality courses and the present is the mention of gender as it affects sexual behavior and trends in marriage. Overall, we think that Soc 340 adds significantly to the University's offerings. It is the only course that focuses on changes in the meaning of sex and love in recent decades, and it examines trends in cohabitation and non-martial births.
