Grading and faculty response

Grades

Students will view a minimum number of 10 screenings per semester.

- Among these required 10 screenings, students are encouraged to watch at least one film from each mode (animation, documentary, experimental, narrative).
- Films that count toward the animation, documentary, and experimental categories requirement will be indicated in a weekly screenings list posted to Carmen/emailed.

Journal entries will be scored and evaluated based on the following criteria:

Written journal submission = 90 points base score:

- Meets proper word length requirements of 250 to 300 words for each journal entry. (15 points)
- Use of proper journal formatting, correct grammar, capitalization, spelling, mechanics. (15 points)
- Use of appropriate filmmaking concepts/terminology. (30 points)
- Expression of thoughtful, personal observations of the film and connection of how concept/ technique contributes to mood and meaning of film. (30 points)

10 points of each journal will be comprised of the biweekly discussion component.

Bi-weekly discussion prompts = 10 points added to journal scores:

- 1 Carmen post of 100 words (10 pts added to Journals 1, 3, 5, 7, 9)
- 2 comments to peer posts (5 points per response = **10 pts** added to Journals 2, 4, 6, 8, 10).

Instructor feedback will be provided in comments to your discussion post.

For each discussion, the instructor will assign a specific technical aspect for discussion, such as "lighting," "framing," "continuity editing," for discussion between peers.

- Students are asked to focus on how the technical element was used and its impact in the films most recently viewed and reported on in the journals.
- Peer comments will engage with similarities and differences in the use of technique in other screened films, how/if the technique was used effectively, differently, unconventionally, etc.
- Discussion will allow students to reformat and summarize thoughts and observations raised in the journals, to begin thinking in a targeted way about how form and film technique impacts content of the film's narrative and viewers' reception to the use of film construction.

This course requires students to attend screenings of a curated selection of films and when available, any associated visiting filmmakers' discussions of their work. To synthesize these viewings, students will submit response writings that apply specific elements of film language to analyze and reflect on the films.

LEARNING OBJECTIVES:

At the completion of this course, students will be able to do the following:

- 1. Demonstrate an understanding of the visual, aural, and narrative conventions that motion pictures employ through written analysis;
- 2. Articulate a critical awareness of how films contribute to defining social norms and how certain filmmakers attempt to intervene in that process through their films;
- 3. Apply the principles and vocabulary of film form and cinematic techniques as tools to analyze and criticize individual films by writing unique and theoretically supported arguments about the films.

COURSE METHODOLOGY:

Each Wednesday, an announcement will be emailed to students via Carmen listing eligible screenings for the upcoming week (Thursday-Wednesday). After viewing films and reflecting on them, each student will submit a journal entry on Carmen by the following Sunday night (11:59pm). Grades and feedback will be posted by the following Friday.

Students will attend a minimum number of 10 screenings per semester. Most screenings at the Wexner Center for the Arts begin at 7 PM. Students should expect to spend approximately \$6.00/per film. <u>Be sure to stop by the Film Studies</u> Office (Hagerty 150) to receive a discount card for an additional \$1 off.

Among these required 10 screenings, students must see at least <u>one</u> film from each mode (animation, documentary, experimental, narrative). Films that count toward the animation, documentary, and experimental mode requirement will be indicated in the weekly screenings list.

RECOMMENDED READING:

A Short Guide to Writing About Film by Timothy Corrigan (2014), published by Longman (9th edition)–excerpts provided on Carmen.

REQUIRED MATERIALS

• A paper journal for taking notes during screenings. This will help you remember important details when writing. (See Corrigan for tips and suggestions.)

All written work for this class must be original and created specifically for this course. Students will practice a critical process that includes the documentation of first impressions and reflection on completed works. The assignment portal for each week's entries opens on Thursday morning and closes at the deadline; late work is not accepted.

For full credit, make sure to upload a picture of your ticket stub and that your writing:

- expresses thoughtful, personal observations of the film within the 250-300 word count
- uses appropriate filmmaking concepts/terminology; proper grammar, spelling, mechanics, capitalization.
 - Note the correct way to cite a film is as follows: *Title in Italics* (Director First and Last Name, Year). Example: *Outrage* (Ida Lupino, 1950)
- connects how concept/technique contributes to the mood and meaning of the film

Points WILL be deducted for entries outside the word count (250-300).

As previously established, keep in mind:

- Always keep your discussion grounded in the film itself. You can bring in outside context or ideas (see <u>Recommended Online Resources</u>), but the crux of your writing should remain anchored in the movie itself.
- You are <u>not</u> required to do additional research. However, if you do, your sources <u>must</u> be properly cited according to MLA conventions. (Purdue OWL has a <u>helpful guide</u>. Skip straight to their <u>electronic</u> <u>sources citation formatting here</u>.)
