To Whom It May Concern:

As chair of the Department of Spanish and Portuguese (SPPO), I am writing to support the proposal for a new certificate in Spanish in Health Care and Human Services. My assessment draws on the recommendations of the department's Undergraduate Studies Committee (led by Dr. Eugenia Romero) and Graduate Studies Committee (led by Dr. Rebeka Campos-Astorkiza). We believe that the certificate has intellectual and professional advantages for both undergraduates who are majoring or minoring in Spanish and for graduate students in professional schools.

As demonstrated in the proposal, the certificate expands on existing strengths within our department. We have numerous faculty members whose research, teaching duties and/or outreach activities focus on Latinx populations, including the following colleagues whose courses are included in the certificate:

- Dr. Glenn Martínez (who has written extensively on Spanish, language policy and health care; regularly teaches SPAN 5501-5502, Spanish in the Health Professions I and II; and spearheads a very successful collaboration/pipeline program with Southwestern City School system aimed at Latinx students who wish to pursue careers in the medical professions);
- Dr. Anna Babel (who specializes in language contact; regularly teaches SPAN 5389S/US Latino Languages and Cultures; and spearheads the BuckIDream Ally program, in support of the university's DACA students;)
- Dr. Ignacio Corona (who regularly teaches courses in the area of Latinx Studies, including SPAN 5461/Latino Urbanism);
- Dr. Elena Foulis (who spearheads oral history projects documenting the lives of Latinx peoples in Ohio –the podcast <u>Ohio Habla</u> and <u>Oral Narratives of Latin@s in Ohio</u>; teaches SPAN 5689S/Spanish in Ohio every semester; and acts as SPPO's service-learning and heritagelearners coordinator); and
- Dr. Paloma Martínez Cruz (who specializes in Latin/x-American performative cultures; teaches SPAN 5620/Gender and Power in the Americas; and spearheads outreach activities such as <u>Onda Latina</u>)

With the exception of one new class (SPAN 5203/Spanish in the Health Care Profession III), all of the 5000-level coursework for this certificate is already available to both undergraduates and graduate students. In essence, the certificate guides students to cluster those courses in an intellectually meaningful way and, upon completion, to receive a credential that can serve as a professional "calling card." In terms of the latter, the certificate guarantees that students will have practical experience using Spanish in health and/or human services by requiring SPAN 5689S/Spanish in Ohio. This service-learning course has well-established partnerships with Latinx-focused organizations in the Columbus-area, including several in health care and human services (as listed on p. 5 of the proposal).

We believe that there is an existing pool of students who would be eager to complete this proposed certificate. In addition to the graduate students in Nursing, Public Health, Social Work and other professional programs who already enroll in Spanish in the Health Care Profession I and II, we have approximately 230 Spanish majors and over 850 Spanish minors. Having completed our "core courses" (3401, 3403, 3450 for minors and majors; and 3404 for majors), they will have the language-skills and fulfill the requirements for the courses in certificate. Indeed, many of those students already take SPAN 5201, 5389, 5461, 5620, 5640 and/or 5689S. We also know that many of our Spanish minors are majoring in areas like Biology and Neuroscience; and given those established interests would find the new certificate particularly attractive.

Finally, the new certificate will allow our department and the university to align with other universities, that already include such certificate programs as part of their curricular offerings. What is unique about our proposed certificate is its ability to serve both undergraduate and graduate population.

Given the diverse pool of students targeted by the certificate (and upon the recommendation of Ms. Bernadette Vankeerbergen), we sought concurrence from the following units: Social Work, Public Health, Nursing, Pharmacy, Medicine, and Speech and Hearing Sciences. Attached to this proposal, you will find evidence of concurrence from the first three units; the latter three have not responded to Dr. Martinez's request from February 19, 2021 (see attached for evidence of his inquiry). Given ASC protocols (i.e. since the two-week period for response has lapsed), we assume concurrence from those three units.

In sum, SPPO encourages the curriculum committees to approve the proposed certificate in Spanish in Health Care and Human Services. We believe that there are substantial advantages for OSU students. We can run this certificate with existing resources, and may even see increased enrollments as students take additional courses in Spanish to complete the certificate.

## Curriculum

**Description**: The Type 1b/3b Certificate in Spanish in Health Care and Human Services consists of a minimum of 12 credit hours. The certificate is designed to enhance the skills of undergraduate majors and minors in Spanish as well as graduate students in the professional colleges of Social Work, Public Health, Nursing, Pharmacy, Medicine, and Dentistry. Students in the certificate program will earn an additional credential that will add high-demand linguistic skills and cultural knowledge to their professional formation in health care and human services.

We hope to roll out the certificate program no later than Autumn 2021. This certificate will be offered in an in-person modality. We anticipate a minimum enrollment of 5 students during the first semester of the program and an additional 10 students during the first year. Our goal is to award 40 certificates between Spring 2021 and Summer 2024.

#### **Program Goals and Objectives:**

- 1. Students will demonstrate theoretical knowledge related to health disparities and language access among Hispanic/Latinx populations in the United States.

## **Curriculum Plan:**

The certificate program will consist of twelve (12) credit hours. Students will take the following three (3) courses: SPAN 5201, SPAN 5202 and SPAN 5689S for a total of nine (9) credit hours. Students will complete the certificate by taking three (3) credit hours of coursework from the approved list of elective courses including SPAN 5203, SPAN 5389, SPAN 5461, SPAN 5620, or SPAN 5640. A total of six (6) credit hours completed in the certificate program (50%) may be applied to the major/minor in Spanish or to another program outside of SPPO.

#### Admissions:

The Certificate program in Spanish in Health Care and Human Services will be open to all OSU undergraduate and graduate students who have completed Spanish 3403/3413 and 3450 (or the equivalent). Undergraduate majors, second majors, and minors in Spanish will be ideal

candidates for the program, but students in all majors with relevant coursework in Spanish will be welcomed.

## **Recruitment:**

The program will be advertised to current undergraduate students in the Department of Spanish and Portuguese through our advisor, postings around the building, and messages on digital signage. The program will be advertised to graduate students in professional programs through our existing connections with the Center for Latin American Studies, the Graduate Interdisciplinary Specialization in Global Health, and the Colleges of Nursing, Public Health and Social Work.

## Acceptance:

Students who demonstrate completion of Spanish 3403/3413 and 3450 or its equivalent at another institution will be admitted to the program.

## **Professional placement:**

Spanish 5689S is an advanced Spanish language course. Students learn about the immigrant and non-immigrant Latina/o/x community in the United States and in Ohio. Outside the classroom, students work with the Spanish-speaking communities of Columbus, Ohio. In addition to regular class meetings, they are required to complete **70 hours** of engagement activities outside of class, at least **50** of those hours are spent working directly in the Latina/o/x community. Health and human services partners for students in this class, include:

- Mt. Carmel Mobile Clinic
- Clínica Latina at Ohio State
- James Center for Health Equity (Outreach to Spanish speaking community)
- Our Lady of Guadalupe Center
- Casa Speech

These faculty members will constitute the oversight committee for the first three years of the program.

Staff members necessary to support this program include:

- a. Rachel Sanabria, Academic Program Manager, SPPO Rachel Sanabria will serve as the Academic Program Manager for the certificate program. Rachel will provide services related to curriculum proposals and course scheduling and enter the course schedule in SIS. As graduate coordinator, Rachel will also serve as advisor and contact person for graduate students who wish to pursue the certificate program.
- b. Michelle Coria, Undergraduate Academic Advisor, SPPO Michelle Coria will serve as undergraduate advisor for the certificate program. Michelle will assist undergraduate students wishing to declare the certificate and provide guidance in fulfilling the requirements.
- c. Elena Foulis, Service-Learning Coordinator, SPPO Dr. Foulis will serve as the service-learning coordinator for the certificate program. Elena will assist students in identifying practicum placements and cultivation of relationships with external stakeholders.

We do not anticipate that additional faculty, staff, or graduate associate support will be necessary for the successful launch of this program during its first three years.

## Assessment Plan

The assessment of the Spanish in Health and Human Services certificate program will take place on a yearly basis. The assessment will be based on both direct and indirect measures.
