Good afternoon,

On Wednesday, May 5th, the Arts and Humanities 1 Panel of the ASC Curriculum Committee reviewed distance learning proposals for Music 2251 and 3348.

Music 2251 was unanimously approved with two contingencies and one recommendation:

- **Contingency:** The Panel would like the GE language added to the syllabus. This language can be found on the ASC Curriculum and Assessment Services website at <https://ascas.osu.edu/curriculum/general-education-goals-and-expected-learning-outcomes>.
- **Contingency:** The Panel would like the department to ensure that the SLDS Disability Statement matches the campus-of-offering on the syllabus. The language for the Columbus campus can be found on the ASC Curriculum and Assessment Services website at <https://ascas.osu.edu/curriculum/syllabus-elements>.
- **Recommendation:** The Panel recommends attaching points to the discussion post assignments to encourage students to complete these assignments.

Music 3348 was unanimously approved with two contingencies and three recommendations:

- **Contingency:** The Panel would like the most up-to-date Academic Integrity statement added to the syllabus. This language can be found on the ASC Curriculum and Assessment Services website at <https://ascas.osu.edu/curriculum/syllabus-elements>.
- **Contingency:** The Panel would like to see further explanation of the course exams, as discussed on page 5 of the course syllabus.
- **Recommendation:** The Panel recommends that explicit explanations of how the GE ELOs are satisfied be included within the course syllabus, as currently they are unsure how the course satisfies them completely.
- **Recommendation:** The Disability Statement is listed twice within the syllabus. The Panel recommends removing the temporary Disability Statement surrounding the COVID-19 pandemic, found on the bottom of page 11 of the syllabus.
- **Recommendation:** The prerequisite for this course is English 1110.xx, but the syllabus mentions the prereq is English 110. The Panel recommends updating this language.

I will return Music 2251 and 3348 to the departmental queue via curriculum.osu.edu in order to address the Panel's requests.
