Thank you for your revision to EDUTL 3101. Jim Fredal, faculty Chair of the ASCC Themes 1 Panel, has reviewed the revision and, at this time, is unable to approve. Please see the following feedback regarding how the Panel's contingency can be fulfilled:

• The first page of the syllabus and the course calendar still indicate that this course is meeting once a week for 80 minutes. This does not fulfill the contact hour expectations for a 3-credit hour course, which requires a course that meets for 80 minutes to meet for twice a week and have appropriate activities for each class meeting. Please update the syllabus to meet the appropriate contact hours for a 3-credit hour course and provide a cover letter that explains the changes made as a result of this feedback.

On Friday, February 25<sup>th</sup>, the Themes Panel of the ASC Curriculum Committee reviewed a GE Theme: Lived Environments proposal for EDUTL 3101. Please see the Panel's feedback below:

EDUTL 3101 was approved with one contingency and two recommendations. As a reminder, the Panel's contingencies must be satisfied in a revision in order to move forward in the approval process while the Panel's recommendations may be implemented when the course is next taught.

- **Contingency:** The reviewing faculty request that the course proposal reflect the correct number of contact hours for a three-credit course, as the calendar currently only lists one meeting a week that does not equal a minimum of three contact hours as required for a three-credit hour course. Additionally, they ask that a brief cover letter be provided that explains the change made.
- **Recommendation:** The reviewing faculty recommend including a definition of what "play" is within the course.
- **Recommendation:** The reviewing faculty recommend carefully reviewing the submitted course proposal for typos and remove text that relates to distance learning courses.

I will return EDUTL 3101 to the departmental queue via curriculum.osu.edu in order to address the Panel's feedback.
