# Course learning outcomes

By the end of this course, students should successfully be able to:

- understand basic conventions of written and spoken German
- be able to recognize and use vocabulary and phrases useful in everyday situations

## **HOW THIS ONLINE COURSE WORKS**

**Mode of delivery:** This course is taught in an asynchronous distance learning mode. This means that you complete 100% of class activities online. There will be opportunities for live interaction with your instructor, as well as activities to connect you to your fellow classmates, but there are no live meetings.

**Credit hours and work expectations:** This is a **1-credit-hour course**. According to Ohio State policy (go.osu.edu/credithours), students should expect around 1 hour per week of time spent on direct instruction (e.g. activities, discussions) in addition to 2 hours of homework (e.g. reading and viewing assignments, quizzes, reflections) to receive a grade of (C) average.

**Mode of delivery:** This course is 100% online. There are no required sessions when you must be logged in to Carmen at a scheduled time.

**Pace of online activities:** This course is divided into **weekly modules** that are released one week ahead of time. Students are expected to keep pace with weekly deadlines but may schedule their efforts freely within that time frame.

**How I communicate with you:** Please be certain you have your CarmenCanvas notifications activated. I recommend you either download the Canvas Student app if you have a smartphone or check the announcements and assignments on this CarmenCanvas course daily. Assignments, including instructions and dates, will be clearly marked on CarmenCanvas as we progress through the semester. For additional instructions, information, or clarifications, I will send out a CarmenCanvas Announcement when necessary.

Attendance and participation requirements: Because this is an online course, your attendance is based on your online activity and participation. The following is a summary of students' expected participation:

## 1. Logging in: AT LEAST ONCE PER WEEK

Be sure you are logging in to the course in Carmen each week, including weeks with holidays or weeks with minimal online course activity. (During most weeks you will probably log in several times.) If you have a situation that might cause you to miss an entire week of class, discuss it with me as soon as possible.

#### 2. Live conversations: FLEXIBLE

Over the course of the semester, you will practice and demonstrate your language skills in seven live conversations. You will be able to schedule these times at a time that is convenient to you and your conversation partner.

#### 3. Office hours: OPTIONAL

Attending my live office hours is optional. If you need to discuss an assignment with me, please contact me at the beginning of the week if you need a time outside my scheduled office hours.

# Descriptions of major course assignments

#### **Homework**

**Description**: Each week, readings, videos, and audio files in Carmen will present the week's content. Often, practice exercises and self-quizzes will be built into this homework, so that you can check your comprehension and mastery of the material as you progress through it. This work will not be collected or graded, but working through it will prepare you to complete the week's assignments

Academic integrity and collaboration: Students may work through homework assignments, including exercises and self-quizzes, with peers.

#### Vocabulary quizzes:

**Description**: Each week's material will contain a vocabulary quiz. Quizzes will be completed in Carmen, and the lowest quiz grade will be dropped.

**Academic integrity and collaboration**: You must complete the quizzes yourself, without any external help or communication

#### **Dialogues**

**Description**: Every other week, you will complete a video dialogue or interview via Zoom. Three of these dialogues will be with other students in the class; the other three will be held with the instructor during office hours. The dialogues will be assessed as pass/no pass, based on whether or not you are able to navigate the situation.

**Academic integrity and collaboration**: Students must carry out their role in the dialogue or interview without assistance.

## Listening exercises

**Description**: Every other week, you will complete a listening exercise based on the week's material. You will access and complete these exercises in Carmen.

**Academic integrity and collaboration**: You must complete the listening exercises yourself, without any external help or communication.

#### End of class assessment

**Description**: There is no final written exam; however, you will be required to schedule a 10-minute long meeting with your instructor for an oral assessment over Zoom. Your instructor will provide you with more details later in the semester
