On Thursday, October 21, the Social and Behavioral Sciences Panel of the ASC Curriculum Committee reviewed a proposal to create a new certificate in the History of Capitalism.

I am pleased to report that the proposal was unanimously approved with **one (1) contingency** and one (1) comment:

- **The Panel appreciates the work the department has done in laying the foundations for this assessment plan. requests that the core of the assessment section be further fleshed out beyond generic statements of intention for the future. In this expanded assessment plan, please include rubrics and/or tables explaining how essays will be evaluated as part of the certificate (or at least provide hypothetical exemplars) so that the Panel has a clearer conception of what this might entail when enacted.**
- The Panel kindly notes that the department might want to keep enrollment numbers in mind as the certificate develops; the existing number of sections for many of the courses the certificate requires are already at capacity, so it may be necessary to add additional sections to accommodate anticipated increase in demand.

I will return the proposal to the queue via curriculum.osu.edu so the department may address the Panel's requests.

On Wednesday, September 22<sup>nd</sup>, the Arts and Humanities 1 Panel of the ASC Curriculum Committee reviewed a proposal to create a new certificate (type 1B) in History of Capitalism.

I am happy to report that proposal was unanimously approved with the following contingencies:

- **Contingency:** The Panel requests (per ASCC guidelines found in the ASC Curriculum and Assessment Operations Manual, page 94: [https://ascas.osu.edu/sites/default/files/2021-09/2021-22\\_asc\\_curriculum\\_and\\_assessment\\_operations\\_manual.pdf](https://ascas.osu.edu/sites/default/files/2021-09/2021-22_asc_curriculum_and_assessment_operations_manual.pdf)) that the program and course prerequisites be placed on the advising sheet.
- **Contingency:** The Panel asks that a sample 4-year program by semesters be provided.
- **Contingency:** On page 2 of the proposal, under Student Enrollment, the College requires the Department to provide an estimate on the number of students they expect the program to enroll at launch. The Panel requests that the proposal provide that estimate.
