Dear ASC Curriculum Committee:

The Department of Arts Administration, Education & Policy (AAEP) seeks to make program changes to the current BAE with Licensure (BAE), our Educator Preparation Program. There is no change to required credit hours, but our proposed changes better reflect the current trends in the field, graduation survey data, and Ohio Department of Education (ODE) guidelines for educator preparation programs. The last major restructuring of the BAE with Licensure took place during the 2012 conversion to semesters. Much has changed since the conversion; including our 2015 move to our new home in Sullivant Hall, the renovation of our art methods classroom/studio space in Ramseyer Hall, contracting art education faculty numbers, and changes to ART curriculum which supports our programs. After consultation with the AAEP Undergraduate Studies committee, the Director of Field Experiences, the AAEP Department Chair, and the Department of Art Chair, Laura Lisbon, we propose the following changes:

- 1). Add a series of options to fulfill the advanced 3-D studio requirement, which will now offer a selection of courses more aligned with Pre-K -12 curricular realities. Instead of **ART-3017 Intro to Sculpture** being the only option, students can alternatively select **ART-3107 Life Sculpture**; **ART-3101 3-D Modeling** or **ART-3003 Introduction to Glass Art.** These courses have either no pre-req or have **ART-2400 3-D** as a pre-req, which all our BAE students are required to take during the **Art Foundations Series.**
- 2). Move required **History of Art** credits (see former BAE Advising sheet) to Studio and History of Art section on new advising sheet for clarity.
- 3). Remove **EDUTL 4005-Urban Teaching & Learning** due to 2019 and 2020 graduate survey data that reported **AE 4000-Pedagogies of Critical Multiculturalism in Teaching Visual Culture** shares the same content but is more focused on art education specifically. Students felt the two courses were duplicative. Syllabi reviews also showed curricular similarities, including many of the same readings and a shared text. In its place, we will now require **EDUTL 5442 Teaching Reading Across the Curriculum** to fulfill Ohio Department of Education's (ODE) state mandated requirement for 3-credit hours in READING IN THE CONTENT AREA (section ORC 3301-24-05-A2 ODE).
- 4). Remove **AE 2520 Digital Artmaking**, which will be shelved under the new GE roll-out (effective AU 2022). BAE Students could already select **AE 2520 Digital Artmaking** or **ART-3000 Digital Image**. Beginning in Fall 2022 the BAE program plan will include just **ART-3000 Digital Image** as a required art foundations course. We will continue to accept **AE 2520** credit hours already taken by Pre-art education applicants as we phase out the course.



5). Change some of our course titles, which are too long and/or outdated for the field of art education. The former names were selected by a now retired faculty member during the 2012 semester conversion. BAE faculty feel the current names do not clearly reflect course content, are confusing to students, nor do they reflect relevant and up-to-date educational language. The proposed names reflect current educational trends (i.e., **Disability and Inclusive Practices** instead of **Special Needs**), and make the course content more explicit for students (name changes are in the process of moving through curriculum.osu.edu).
