Good afternoon,

On Thursday, November 18, the Social and Behavioral Sciences Panel of the ASC Curriculum Committee reviewed the course proposals for SHS 5785 & 8936. Please find below the Panel's feedback for these courses. {N.B. **Contingencies (bolded)** require revision and resubmission to the Panel chair, while *recommendations (italicized)* or comments are suggestions from the Panel that an instructor can implement at their discretion when the course is taught.}

- 1. SHS 5785 | Unanimously approved with five (5) contingencies and one (1) recommendation
 - Contingency: The Panel requests that page 2 of the syllabus be amended to reflect
 the fact that there are both required synchronous log-in times as well as lectures
 posted online that students must watch asynchronously.
 - Contingency: The Panel asks that the course calendar outline benchmarks and expectations for students on a day-by-day basis (rather than weekly), including specific due dates for any assignments.
 - Contingency: The Panel requires that specific page-range counts are included on the syllabus for each assigned reading.
 - Contingency: The Panel requests that the syllabus clarify how and where students will compose and submit quizzes whether on Carmen, or in another format.
 - Contingency: Online versions of courses need to be equivalent in content to their in-person counterparts. In this regard, the Panel has questions about the relative difficulty of the two versions of the class; the in-person format seems directed toward MA/PhD students, while the online proposal seems more appropriate for undergraduate students. The Panel asks that the department provide a statement to account for this apparent disparity.
 - Recommendation: On page 8 of the syllabus, the midterm and final exams are described as asynchronous, but will they be delivered using a lockdown browser? Also, do students have the full 12 hours to complete the exam, or only a specified amount of time within that 12-hour window to finish? As the instructor finalizes the exam parameters, the Panel suggests considering the ways students taking an exam at different times during a 12-hour period might potentially undermine the effectiveness of a lockdown browser.
- 2. SHS 8936 | Unanimously approved with **three (3) contingencies**, *two (2) recommendations*, and one (1) comment
 - Contingency: The course schedule needs to account for all 14 weeks of the term; at present, only 12 weeks are fully accounted for in the syllabus.
 - Contingency: Integrity statements for each individual assignment are a

requirement for online syllabi; the Panel requests that these statements be added to each assignment in the syllabus so that it is clear that students should and must work on their own.

- Contingency: The Panel asks that the department include the most up-to-date version of the University's disability services statement, which can be found here: https://asccas.osu.edu/curriculum/syllabus-elements
- Recommendation: The Panel recommends that the department include the most up-todate version of the Title IX statement, which can be found here: https://asccas.osu.edu/curriculum/syllabus-elements
- Recommendation: The Panel suggests revising the course assignment points chart (found on page 6 of the syllabus), which currently gives students a bonus 30 points as totaled.
- Comment: Why does the form in curriculum.osu.edu say that the course does not meet on campus? DL classes technically meet "on" campus even though delivered online.

I will return SHS 5785 & 8936 to the department queue via curriculum.osu.edu in order to address the Panel's requests.
