On Thursday, December 16<sup>th</sup>, the Themes Panel of the ASC Curriculum Committee reviewed a new GE Theme: Lived Environment proposal for History 2701.

The Panel unanimously approved the request with two contingencies and two recommendations:

- **Contingency:** The reviewing faculty request that a statement explaining how the GE Theme: Lived Environments ELOs will be satisfied be included underneath the GE Goals and ELOs, as this is a requirement of General Education courses within the College of Arts and Sciences.
- **Contingency:** The reviewing faculty request the addition of GE Theme: Lived Environment ELO 1.2 to the course syllabus, as it is currently missing. - **Recommendation:** The reviewing faculty recommend removing the grade of D- from the grading scale, as The Ohio State University does not award the letter grade of D-.
- **Recommendation:** The reviewing faculty recommend tying the course description to the GE Theme: Lived Environments to help students help connect this course to the GE Theme.
