Dear Dr. Smith,

The Department of Arts Administration, Education & Policy in the College of Arts and Sciences seeks to change the name of the MA in Art Education on-campus program in an effort to signify that it differs from the MA in Art Education online program. The new title for the on-campus program will be MA in Art Education & Public Pedagogy. The curriculum pathway that students take for the on-campus MA in Art Education has an emphasis on connecting art education theories to pedagogy and practices in sites of education and learning inside schools and museums, as well as in community spaces that are outside of the four walls of a formal classroom. Public pedagogy refers to the educative interruptions that can happen in public spaces. Students in the on-campus program engage in a considerable amount of research aimed to understand artistic and aesthetic approaches to learning in the public sphere. Students reflect on these comprehensive teaching practices through critical reflection, data collection and analysis. They use critical thinking, evidence-based principles and current cases to analyze situations, issues, and problems impacting contemporary art education theory and practice. The name change will better align with the expansive sites of inquiry that the on-campus students engage in compared to students in the online MA in Art Education program.

The name change is aimed to better identify how the on-campus program differs from the online program with the same name. There are no curriculum changes alongside this title change; however, students in the on-campus MA program will not be able to take more than 3 online classes (not to exceed 10 hours total) to count towards their MA degree. The title change will not affect the degree that they will receive, it will still be a Master of Arts. Therefore, students who are already enrolled in the program can graduate under the original name/be grandfathered in, or opt for the new program name. Additionally, there are no administrative, curricular, faculty or support service changes.
