On Thursday, June 9th, the Themes Panel of the ASC Curriculum Committee reviewed a new GE Theme and High-Impact Practice: Service Learning proposal for Music 2032S. Please see below for the Panel's feedback.

The Panel unanimously approved the request with one contingency and one recommendation. As a reminder, the Panel's contingency must be satisfied in a revision via curriculum.osu.edu while the Panel's recommendation may be implemented when the course is next taught.

- **Contingency:** The reviewing faculty ask that all GE Goals and ELOs for the GE Theme: Health and Well-being be added to the course syllabus, per a requirement of all General Education courses. The GE Goals and ELOs can be found on the Office of Academic Affairs webpage at: <https://oaa.osu.edu/ohio-state-ge-program>.
- **Recommendation:** The reviewing faculty would like to remind the School of Music to ensure all syllabus statements (such as the Disability Statement, Academic Misconduct Statement, Title IX Statement, etc.) are accurate for the campus-of-offering when the course is next taught.

I will return Music 2032S to the School's queue via curriculum.osu.edu in order to address the Panel's feedback.
